**NOTIFICATION BY PRESIDENT IN RESPECT OF ENTITIES IDENTIFIED
BY THE UNITED NATIONS SECURITY COUNCIL: SECTION 25 OF THE
PROTECTION OF CONSTITUTIONAL DEMOCRACY AGAINST TERRORIST
AND RELATED ACTIVITIES ACT, 2004**

I, Thabo Mvuyelwa Mbeki, President of the Republic of South Africa, hereby, in terms of section 25 of the Protection of Constitutional Democracy against Terrorist and Related Activities Act, 2004 (Act No. 33 of 2004), give notice that the Security Council of the United Nations, under Chapter VII of the Charter of the United Nations, has identified the entities mentioned in the Annexure, as being-

- (a) entities that commit, or attempt to commit, any terrorist and related activity or participate in or facilitate the commission of any terrorist and related activity; or

- (b) entities against whom Member States of the United Nations must take the actions specified in the Resolutions of the said Security Council, in order to combat or prevent terrorist and related activities.





Annexure A

UPDATING OF THE CONSOLIDATED LIST OF INDIVIDUALS AND ENTITIES BELONGING TO OR ASSOCIATED WITH THE TALIBAN AND AL-QAIDA ORGANISATION AS ESTABLISHED AND MAINTAINED BY THE 1267 COMMITTEE OF THE SECURITY COUNCIL OF THE UNITED NATIONS

SECURITY COUNCIL AL-QAIDA, TALIBAN SANCTIONS COMMITTEE APPROVES CHANGES TO CONSOLIDATED LIST

Significant changes to the Consolidated List, approved by the Al-Qaida and Taliban Sanctions Committee, were introduced on 25 July 2006 as indicated below.

Permanent reference numbers

In order to address problems caused by the fact that the number appearing in front of listed individuals and entities is subject to change every time the Consolidated List is updated, the Committee is hereby replacing sequential numbering with permanent reference numbers.

The permanent reference number consists of three letters and two numbers. The first letter, T or Q, indicates Taliban or Al-Qaida. The second letter, I or E, indicates individual or entity. The third letter represents the first letter of the last name. The first number represents the order in which the individual or entity was added to the Consolidated List. The second number represents the year the individual or entity was added to the Consolidated List.

As an example, the permanent reference number assigned to Usama Muhammed Awad bin Laden is QI.B.8.01 where Q indicates that he appears on the Al-Qaida section of the Consolidated List, I indicates that he is an individual, B that his last name starts with a B, 8 that he was the eighth individual to be added to the Al-Qaida individuals section of the Consolidated List, and 01 that he was added in 2001.

As the reference numbers are permanent the numbers assigned to an individual or an entity will be maintained if sanctions against that individual or entity are lifted and the individual or entity is placed in the "De-listed" section.

Member States are encouraged to make use of the permanent reference numbers in their future communications with the Committee.

Alphabetization of the Taliban section of the Consolidated List

Since the inception of the Consolidated List individuals on the Taliban section of the List have been arranged according to their designation at the time when the Taliban controlled territory in Afghanistan whereas individuals associated with Al-Qaida have been arranged alphabetically.

To address this inconsistency and to ease implementation the Committee has decided to arrange both the Taliban and the Al-Qaida sections of the Consolidated List alphabetically.

Addition of original script

To alleviate concerns regarding the accuracy of the transliteration of names on the Consolidated List and to ease implementation by Member States the Committee has decided to include, where possible, the names of listed individuals in original script as the names would appear in the individuals' travel documents.

At this time, original script has been added for 155 individuals on the Al-Qaida section of the Consolidated List (152 in Arabic script and three in Cyrillic script). With the assistance of the Monitoring Team, the Committee intends to continue its work to add original script where possible. When submitting names for addition to the Consolidated List to the Committee, Member States are encouraged to provide the names in both transliteration and original script.

Additions and corrections to the Consolidated List

The Committee has also approved a number of additions and corrections to the identifying information relating to 13 individuals on the Taliban section of the Consolidated List, 14 individuals on the Al-Qaida section of the Consolidated List, and nine entities on the Al-Qaida section of the Consolidated List (the changes have been marked with cross-through and underline in the entries below).

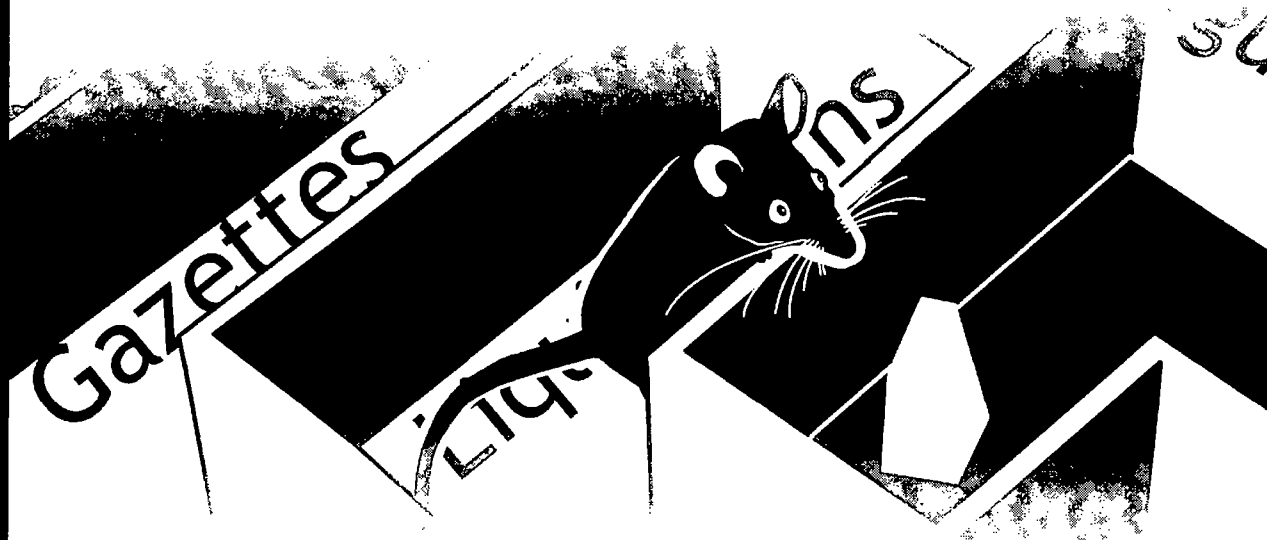

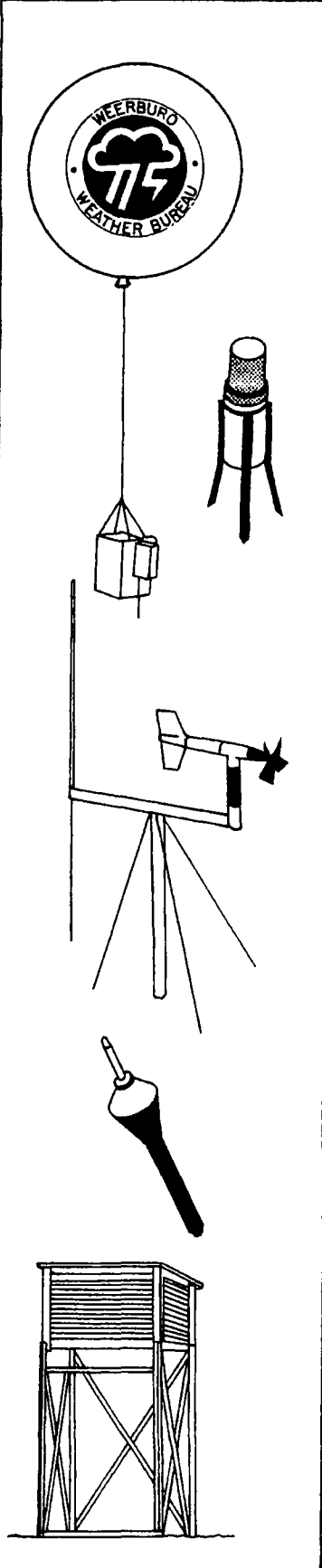

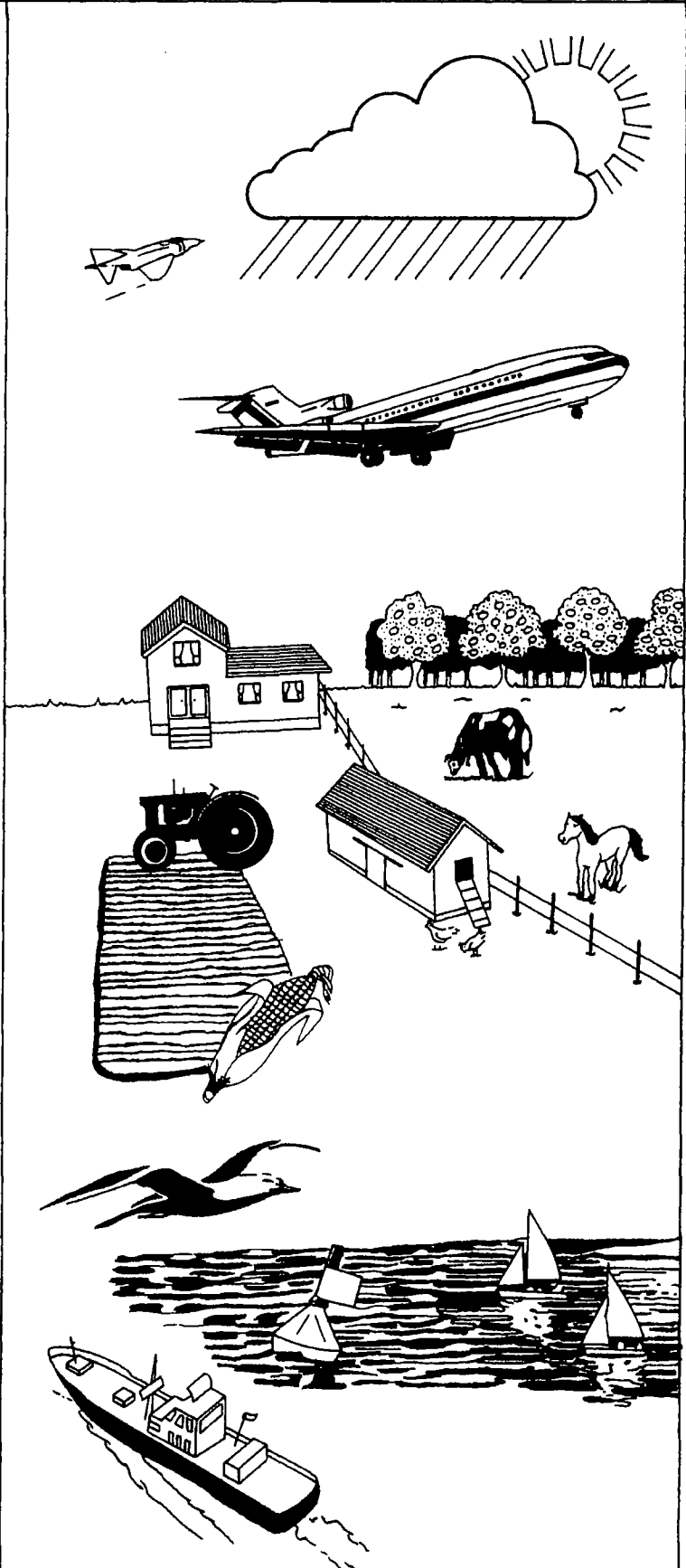
