SKILLS DEVELOPMENT ACT, 1998 (ACT NO. 97 OF 1998) AS AMENDED**APPOINTMENT OF THE MAPPP SETA ADMINISTRATOR**

I, Dr Vanguard Mbuyiseli Mkosana, Director-General: Labour, by virtue of powers vested in me by section 15(2) of the Skills Development Act, 1998 (Act No. 97 of 1998) hereinafter referred to as the Act, hereby suspend the Board and the operation of the gazetted constitution of Media, Advertising, Publishing, Printing and Packaging Sector Education and Training Authority (MAPPP SETA) as directed by the Minister of Labour in terms of section 15 (1) of the Act; and

Appoint Price Waterhouse Coopers as Administrator for a period of six (6) months from the date of publication of this notice to take over the administration of the MAPPP SETA that was established in terms of Government Notice No. R 27445 of 31 March 2005, and the appointment which may be reviewed at the expiry of the said period.

The powers and duties of the Administrator shall be as indicated in schedule 1 of this Notice.

SCHEDULE 1**POWERS AND DUTIES OF THE ADMINISTRATOR**

- 1. The powers of the Administrator are as follows:**
 - (a) take over the role of accounting authority of the MAPPP SETA as provided for in the Public Finance Management Act, 1999 (Act No.1 of 1999) and the relevant regulations;
 - (b) establish if necessary, with the Minister's approval, chambers as provided for in Sections 12 and 13 of the Act;
 - (c) determine the terms and conditions of employment of the executive officer, chief financial officer and other employees of the MAPPP SETA where it is necessary;
 - (d) formulate general governance policies of the MAPPP SETA in terms of any applicable law;
 - (e) suspend, institute disciplinary proceedings or replace, when it is necessary, any of the officials of MAPPP SETA for reasons as contemplated in Section 15 (1) (a) to (e) of the Act;
 - (f) consult widely with the relevant stakeholders and may develop a constitution for the MAPPP SETA in terms of section 13 of the Act and other relevant legislation for approval and publication by the Minister of Labour;
 - (g) facilitate the appointment of a new MAPPP SETA Board;
 - (h) manage the MAPPP SETA funds in liaison with the Department of Labour using relevant provisions of the Act and as provided for in the Public Finance Management Act, 1999 and the relevant Regulations;
 - (i) make rules relating to MAPPP SETA and chamber meetings, financial matters, general procurement and administrative matters which are in accordance with the provisions of the Constitution of the Republic of South Africa, 1996, the Act or any other applicable law;

- 2. The duties of the Administrator shall include the following:**
 - (a) perform the functions of the MAPPP SETA in terms of the Act, the Public Finance Management Act, 1999 as amended and other relevant legislation;
 - (b) implement National Skills Development Strategy within the MAPPP SETA;
 - (c) submit on a monthly basis progress reports regarding the effective functioning of the MAPPP SETA to the Director-General: Labour;
 - (d) fund all the processes and activities pertaining to the powers and duties as an administrator from the MAPPP SETA funds;
 - (e) perform any such other function as may be delegated or instructed by the Minister or Director-General from time to time.
