NOTICE 313 OF 2008**DEPARTMENT OF WATER AFFAIRS AND FORESTRY****PUBLICATION OF THE EXPLANATORY SUMMARY OF THE SOUTH
AFRICAN NATIONAL WATER RESOURCES INFRASTRUCTURE AGENCY
LIMITED BILL**

The Minister of Water Affairs and Forestry intends introducing the South African National Water Resources Infrastructure Agency Limited Bill, 2008 in the National Assembly during February 2008. The explanatory summary of the Bill is hereby published in accordance with Rule 241 of the National Assembly.

The Bill provides:

For the incorporation and establishment of The South African National Water Resources Infrastructure Agency as a juristic person wholly owned by the State to be tasked with the responsibility to administer, fund, finance, develop, alter, maintain, rehabilitate, refurbish, operate, manage and provide advisory services in respect of national water resources infrastructure; to provide for the disestablishment of the Trans-Caledon Tunnel Authority; and to provide for matters connected therewith.
