**NOTICE 315 OF 2008****DEPARTMENT OF HOME AFFAIRS  
PUBLICATION OF EXPLANATORY SUMMARY OF THE REFUGEES  
AMENDMENT BILL, 2008**

The Minister of Home Affairs intends introducing the Refugees Amendment Bill, 2008 in the National Assembly. The explanatory summary of the Amendment Bill is hereby published in accordance with Rule 241(1)(c) of the Rules of the National Assembly.

The Amendment Bill provides for—

- (a) the insertion of certain definitions;
- (b) the delegation of powers;
- (c) certain matters with regard to the establishment of Refugee Reception Offices;
- (d) the dissolution of the Standing Committee and the Refugee Appeals Board;
- (e) the establishment of the Refugee Appeals Authority;
- (f) the clarification and revision of procedures relating to refugee status determination;
- (g) the obligations and rights of asylum seekers;
- (i) the repeal of certain obsolete provisions; and
- (j) certain technical corrections.
