

**DEEDS REGISTRIES ACT, 1937 (ACT No. 47 OF 1937) : AMENDMENT OF
REGULATIONS**

Under section 9(9) of the Deeds Registries Act, 1937 (Act No. 47 of 1937), I, Lulama Xingwana, Minister for Agriculture and Land Affairs, approve the regulations contained in the Schedule, made by the Deeds Registries Regulations Board under section 10 of the said Act. The regulations will come into operation one month from the date of publication of this Notice in the *Gazette*.

SCHEDULE

Definitions

1. In this Schedule "the Regulations" means the regulations promulgated by Government Notice No. R.474 of 29 March 1963, as amended.

No fees shall be levied by a registrar in respect of the performance of any act prescribed in section 3(1)(w) of the Act.



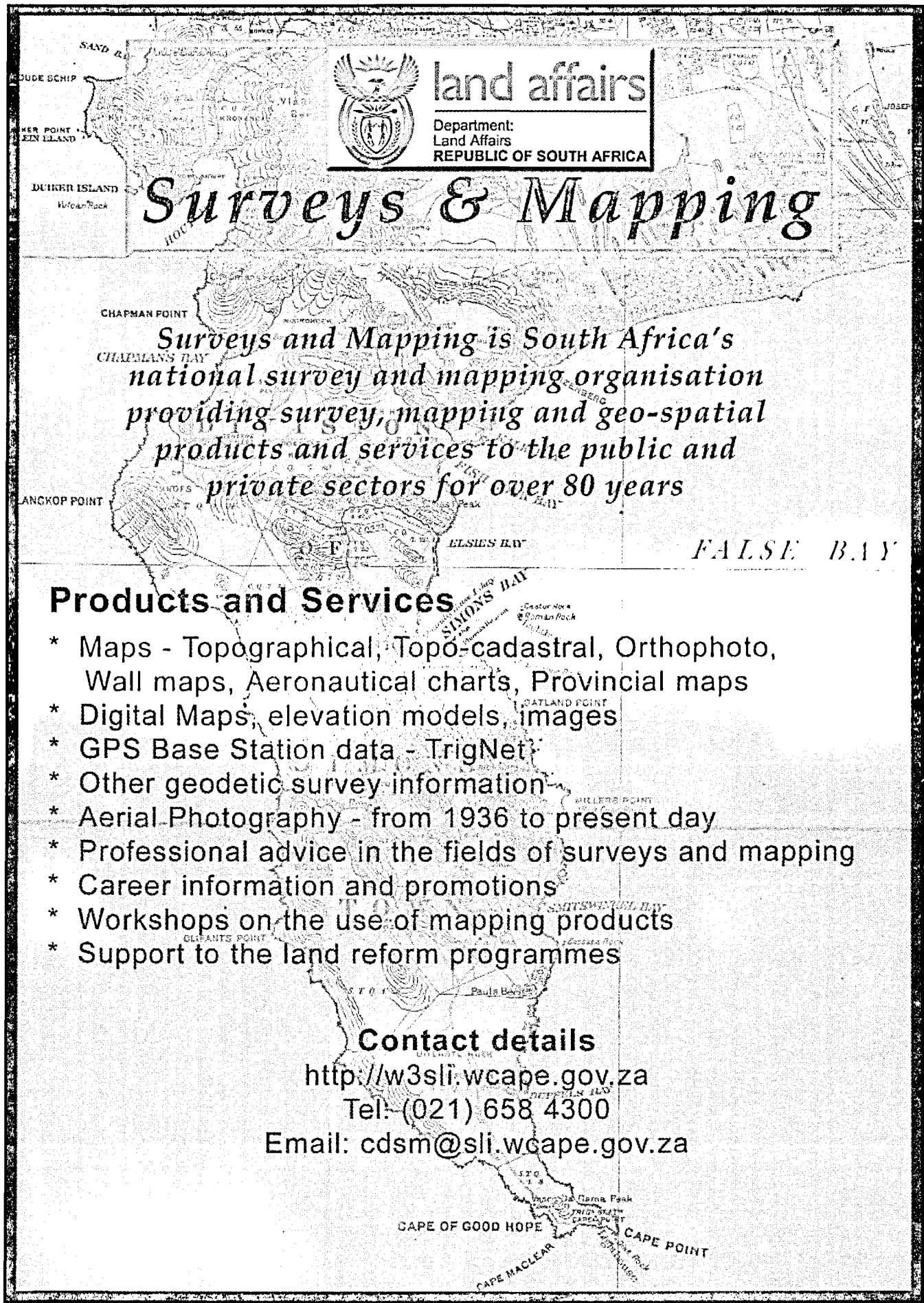
