APPLICATION FOR THE AMENDMENT OF AN INDIVIDUAL LICENCE CONDITIONS

CAPRICORN FM (PTY) LTD

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of the provisions of section 10(2) of the Electronic Communications Act, No. 36 of 2005, that it has received an application from Capricorn FM (Pty) Ltd ("the applicant") for the amendment to broadcasting service licence in terms of section 10(1) of the Act.
2. The amendment is sought to enable the applicant to expand its coverage in the Limpopo Province. The applicant is proposing to broadcast to an additional site in the Pankop area on the frequency modulation 91.7.
3. The effective date of the amendment would be the date on which the Authority's decision on the application would be published.
4. The applications, relevant schedules and any representations received pursuant thereto would be made available and open for inspection by interested parties in the Authority's library during the Authority's normal office hours.
5. Interested parties are invited to lodge written representations in relation to the application within fourteen (14) working days of the date of publication of this notice which will expire on 26 November 2008. Persons who lodge representations in terms hereof must simultaneously indicate whether they also require an opportunity to make oral representations to the Authority.
6. Capricorn FM (Pty) Ltd shall be entitled to respond in writing to written representations made by interested persons on the proposed amendment, and such written response must be lodged with the Authority within twenty one (21) days of the date of publication of this notice in the *Government Gazette*. Capricorn FM (Pty) Ltd must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written representations.
