#### SOUTH AFRICAN WEATHER SERVICE ACT, 2001 (ACT NO. 8 OF 2001)

#### REGULATING COMMITTEE FOR METEOROLOGICAL SERVICES: NOMINATIONS FOR THE APPOINTMENT OF SUITABLE PERSONS AS MEMBERS

In terms of section 20 of the South African Weather Services Act, 2001 (Act No. 8 of 2001), the Minister of Water and Environmental Affairs must establish a Regulating Committee for Meteorological Services. The members of the Committee consist of five (5) persons appointed on a part-time basis by the Minister of whom at least three (3) are not officials of any State Department.

Interested parties are invited to nominate suitable persons to be appointed as members of the Regulating Committee for Meteorological Services in terms of section 5(3) of the Act. Nominations must be accompanied by an acceptance letter from the nominee as well as the Curriculum Vitae of the person or persons being nominated. The nomination must, at a minimum, include the following:

- The personal details, including postal and residential address and contact numbers of the nominee;
- Nominee's qualifications and/or experience with reference to the criteria contained in subsection 5(2) of the Act; and
- Other relevant information
