NOTICE 227 OF 2011
DEPARTMENT OF TRANSPORT
CIVIL AVIATION ACT, 2009 (ACT NO 13 OF 2009)
CIVIL AVIATION REGULATIONS, 2011

In Government Notice No. 152 dated 14 March 2011, the Minister of Transport indicated his intention, in terms of section 155(1) of the Civil Aviation Act, 2009 (Act No. 13 of 2009) to make the Regulations as contained on the South African Civil Aviation Authority website at www.caa.co.za. In order to achieve this objective, written comments were invited until **14 April 2011**.

It is, however, considered necessary to include additional changes to certain Parts of the Regulations, e.g Parts 61 (Pilot Licensing); Part 64 (Cabin crew licensing); Part 65 (Air traffic service personnel licensing); Part 67 (Medical certification) and Part 91 (General operating and flight rules). These additional changes have been posted on the SACAA website and electronic copies thereof may be requested from the persons mentioned below.

Due to these additions, the closing date for comments has been extended until **13 May 2011**.
