DUMPING OF SCREW STUDDING (RODS THREADED THROUGHOUT) OF
STAINLESS STEEL AND STEEL (COMMONLY KNOWN AS THREADED RODS)
ORIGINATING IN OR IMPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA**

On 23 September 2011, the International Trade Administration Commission of South Africa (the Commission) formally initiated an investigation into the alleged dumping of screw studding (rods threaded throughout) of stainless steel and steel (commonly known as threaded rods) originating in or imported from the People's Republic of China (PRC). Notice of the initiation of the investigation was published in Notice No. 647 of *Government Gazette* No. 34612 dated 23 September 2011.

The application was lodged by the South African Fasteners Association (SAFMA) on behalf of the major producers of the subject products in the SACU, which claimed that the allegedly dumped products are causing it material injury and a threat of material injury.

The investigation was initiated after the Commission considered that there was *prima facie* evidence to show that the subject products were being imported at dumped prices, and is causing material injury and a threat of material injury to the SACU industry.

On initiation of the investigation, the known foreign producers of the subject product in the PRC were sent foreign manufacturer/exporter questionnaires to complete. Importers of the subject products were also sent questionnaires to complete.

After considering all parties' comments and verification of the information submitted, the Commission made a preliminary determination that the subject products were not being dumped on the SACU market. However, the Commission made a preliminary determination that the Applicant is currently experiencing material injury and a threat of material injury. Since the Commission made a preliminary determination that no dumping is taking place, it did not make a preliminary determination regarding causality.

The Commission therefore made a preliminary determination to terminate the investigation.

The Commission's detailed reasons for its preliminary determination are set out in Commission Report No. 400 (preliminary report).

Interested parties are invited to comment on the Commission's preliminary report.

The Commission will take all the comments on its preliminary report into consideration before making its final determination and recommendation to the Minister of Trade and Industry.

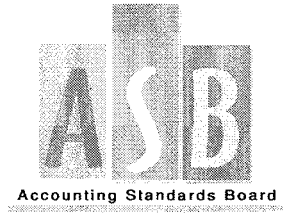
