1. LEGAL BASIS FOR THE INQUIRY

The Competition Commission (“the Commission”) will conduct a market inquiry into the supply and distribution of Liquid Petroleum Gas (“LPG”) in South Africa in terms of Chapter 4A¹ of the Competition Act, 89 of 1998 (as amended) (“the Act”) and in keeping with the purpose and functions of the Commission set out in section 2 and section 21 of the Act respectively. Section 21 of the Act calls on the Commission to, *inter alia*, “implement measures to increase market transparency” and “advise, and receive advice from, any regulatory authority”. In order to fulfil these functions, and in line with the purpose of the Act, Chapter 4A of the Act enables the Commission to conduct market inquiries in respect of the “general state of competition in a market for particular goods or services, without necessarily referring to the conduct or activities of any particular named firm”.² A market inquiry is thus a general investigation into the state, nature and form of competition in a market, rather than a narrow investigation of specific conduct by any particular firm.

The Commission is initiating an inquiry into the LPG sector because it has reason to believe that there are features of the sector that prevent, distort or restrict competition. The Commission further believes that conducting this inquiry will assist in understanding how it may promote competition in the LPG sector, in furtherance of the purpose of the Act. One of the prerequisites to commence a market inquiry is that the Commission must develop and publish Terms of Reference (“ToR”) for the market inquiry. These ToR must include, “at a minimum, a statement of the scope of the inquiry and the time within which it is expected to be completed. In accordance with these provisions, this ToR sets out the scope of the market inquiry, as well as the expected timelines for the inquiry.

Although the ToR delimits the scope of the market inquiry as currently envisaged, additional and related matters not identified herein may arise during the conduct of the inquiry. If the Commission believes that the ToR should be amended in any way, either through the addition of new matters or exclusion of matters currently identified herein, the ToR may be amended in terms of section 43B (5) of the Act.

2. PRODUCT OVERVIEW

LPG is a liquefied and mixed gaseous hydrocarbon³. Although there are many variations of LPG, it is primarily made up of propane (60%) and butane (40%)⁴, which are compressed into liquid form for ease of transport, storage and handling. LPG is produced as part of a chemical process either as a by-product of the refinery process or it can be extracted “from oil or ‘wet’ natural gas streams as they emerge from the ground.”⁵ It can also be produced by blending the two ingredients together. It is stored in tanks, mainly in liquid form and transported by road tanker trucks or in cylinders. LPG is used in many applications, however, the basic product is homogenous in the sense that the physical features and the quality of the product supplied by each supplier is the same.

LPG is primarily used as a thermal fuel and is consumed by industrial, commercial and household consumers. It burns cleanly, releasing very few sulphur emissions, and posing no ground or water pollution hazards. There are over a thousand applications of LPG particularly in commercial and industrial businesses. In particular, LPG is used in the following industries:

- Industrial customers: for heating purposes where a readily controlled temperature is needed, i.e. motor vehicle paint shops or as fuel for fork lift trucks within warehouses etc.
- Commercial: This includes, for example, a shopping centre with a number of restaurants which may have one bulk tank with LPG reticulated to individual restaurants/stores.
- Households: LPG is mainly used by households for heating and cooking

There are various possible substitutes for LPG depending on the intended end use; these include natural gas, electricity, biomass (wood), fossil fuel (coal) and solar equipment⁶. LPG generally differentiates itself from other energy sources on the basis of portability, convenience, low sulphur content, controllability and its clean burning nature. The confines

of the market will become clearer during and after the market inquiry however the Tribunal has previously accepted a distinct market for LPG separate from other sources of energy⁷

3. THE SOUTH AFRICAN LPG SECTOR

Approximately 300 000 tons of LPG is manufactured and sold in South Africa annually generating a turnover of about R1.5 billion. The sector is however still characterised by limited supply with imports supplementing the domestic supply. Most of the LPG produced in South Africa is consumed by industrial users such as manufacturing plants and commercial users such as shopping centres with only marginal quantities consumed by households. Only about 3% of households in South Africa use LPG as their main energy source for cooking.⁸ The wholesaling of LPG is relatively capital intensive and requires investment in bulk transporters tankers, bulk storage facilities, cylinder filling plant, cylinders, cylinder delivery vehicles and installation on customer's premises⁹.

The LPG sector is highly regulated mainly to ensure the safety of both suppliers and end-users as the gas is hazardous. The Occupational and Health and Safety Act (No. 85 of 1993) and other fire safety regulations and municipal by-laws have made provisions which ensure that the safety component of LPG receives priority. The Department of Energy ("DoE") also sets strict regulations which ensure that infrastructure used to import and transport imported LPG meets the safety requirements of the country.

In addition to safety regulation, the price of LPG is also regulated at certain levels of the value chain in terms of the Petroleum Products Act. The DoE regulates the Maximum Refinery Gate Price of LPG ("MRGP") which is the price at which refineries sell LPG. This is done to ensure that LPG is priced in such a way that is aligned to strategic thrust of the DoE to strive for security of energy supply through diversity of energy supply including LPG. The MRGP is also designed to support the importation of LPG.¹⁰ The biggest single factor that affects the price of LPG is the price of crude oil. The volatility of the crude oil price causes

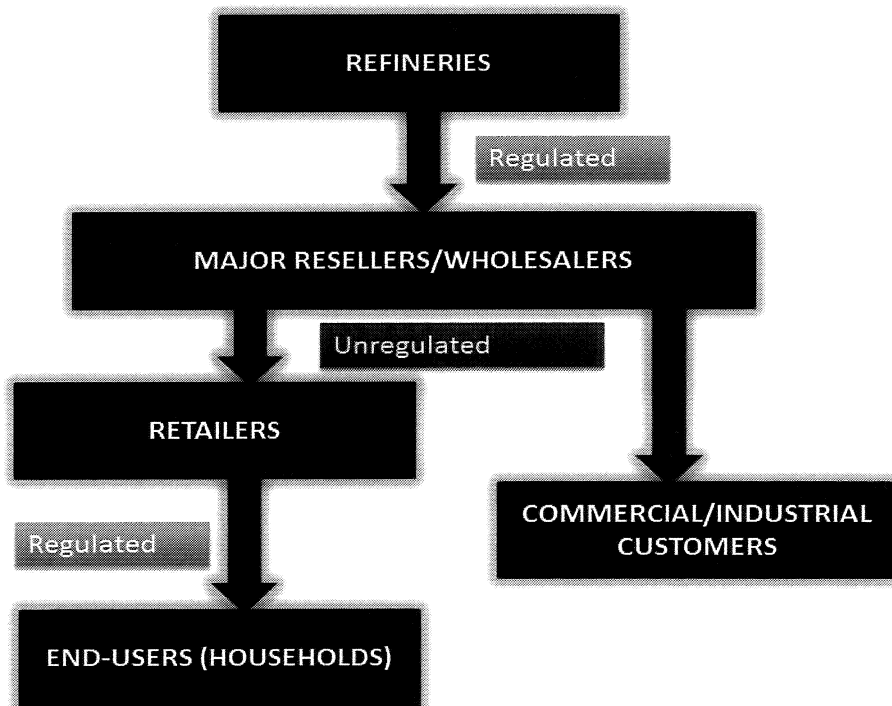

constant fluctuations in the price of LPG¹¹. The LPG industry faces shortages from time to time, mainly in the winter months, largely due to unplanned shutdowns of refineries, late start-up after planned maintenance and limited storage facilities. Notwithstanding the shortages, importing is challenging as import facilities are limited and there are suggestions that imports are uneconomic at the MRGP.

The storage of LPG is also licensed and regulated by the National Energy Regulator of South Africa (“NERSA”). NERSA regulates LPG marine loading facilities, pipelines and storage facilities when the LPG is in liquid form. The Commission understands that the Government strategy has been to consolidate petroleum and petroleum product regulation under a single Act/regulator. This aspect will be interrogated further in the market inquiry.

The LPG value chain includes refineries, distributors/resellers, retailers and other stockists. The diagram below shows the different levels of the value chain before they are discussed thereafter:

Figure 1: LPG Value Chain



3.1. The Refineries

There are six refineries in South Africa involved in the production and supply of LPG. The refineries are generally dispersed across the country and are owned by the major oil companies. As noted above, LPG is regulated at this level of the value chain by DoE which sets the MRGP. The Commission understands that the refineries allocate a certain proportion of their total LPG supply to wholesalers; this may have an impact on competitive dynamics in the downstream wholesale market. The Commission has identified the following refineries in South Africa:

- Sapref (Durban)
- Sasol's Synfuels (CTL¹²) (Secunda)
- PetroSA's Synfuels (GLT¹³) (Mossel Bay)
- Natref (Sasolburg)
- Enref (Durban)
- Chevref (Cape Town)

LPG is also imported into South Africa via three small import facilities. Afrox imports through a facility owned by *Island View storage* located in Richard's Bay which has a 3500 ton working capacity. Easigas imports through facilities with a maximum holding capacity of 1600 tonnes in Port Elizabeth owned by Shell. There is also an import facility in Durban with a maximum holding capacity of 1000 tons owned by Sapref. The import facility owned by BP SA located in East London has been mothballed however there are plans to develop an import facility in Saldanha Bay¹⁴.

3.2. Resellers/Distributors

Major Resellers (MR's), according to the Petroleum Products Act 1977 ("PPA") are firms that play a distribution role for bulk gas, either distributing it in bulk or repackaging LPG to better suit customer demands. The LPG market in South Africa is primarily serviced by four large MR's, namely Afrox, Easigas, BPSA, and Total Gas though there are other small players in the market. There other smaller players at this level of the LPG value chain including Reatile Gas, Sol Gas, KayaGas etc. BP SA and Enref, as of August 2013, were the only firms which are vertically integrated in the LPG supply chain, being involved in both manufacturing and distributing.

Bulk LPG is purchased by the MR's, either from the oil refineries or imports. The gas is then transported either by rail or road to three possible destinations, namely:

- Directly to industrial and commercial end-user. These customers would generally store the LPG in bulk storage tanks provided by the MR on their premises. The supply to commercial entities often involves the reticulation of LPG to multiple end-users through a system of pipes connected to one or more storage tanks. Generally, the MR would also provide other equipment such as vaporizers, fire-fighting equipment and gas meters. .
- The MR's storage facilities and/or cylinder filling plants located in different parts of the country. The primary use of LPG supplied to these facilities would be to fill into cylinders at an adjacent filling plant owned by the MR. The cylinders are then supplied to commercial customers and end-users in LPG cylinders. Alternatively the LPG is supplied by the MR from the storage facility to bulk LPG industrial and commercial end-users such as shopping centres.
- LPG is stored in equipment supplied by the MR at the premises of the retailer who then fill the LPG into gas cylinders. All equipment, including filling platforms, cylinder filling scales, fire extinguishing equipment and ancillary equipment required to fill the gas cylinders is provided by the MR. LPG cylinders are then sold off to individual end-users and private households.

The Commission also understands that there are firms which trade at this level of the market which are not 'conventional' wholesalers of LPG. These firms, referred to as 'brokers', receive an allocation of LPG from the refineries and on-sell this (the allocation) to the wholesalers. These firms therefore do not participate actively in the wholesaling of LPG and may not even have the necessary equipment but rather play the role of a middleman between refineries and wholesalers in instances where they have managed to secure allocation. Due to the shortages in LPG supply, these firms may have an impact on competitive dynamics at the wholesale level of the market. This impact will be explored during the market inquiry.

3.3. Retailers

LPG is sold at the retail level in cylinders mainly used by household customers. This level of the market is largely fragmented with LPG being sold from a variety of outlets; these include:

filling station, grocery supermarkets and hardware stores. The Commission has provisionally identified the following dynamics at this level of the value chain:

- LPG is supplied in branded cylinders by the resellers to retailers who on-sell to end-users.
- LPG retailers are usually contracted and branded to a particular producer or wholesaler who owns storage and filling equipment. This is particularly the case for filling stations affiliated with the vertically integrated refineries.
- LPG usually yields a small portion of the turnover for most of these outlets and has small margins because the price is regulated.
- Transportation and storage costs in the supply chain result in higher prices to consumers however the small size of the market has not warranted larger-scale infrastructural investment for importation or local optimisation and distribution of bulk LPG

The demand for LPG in South Africa seems to be growing as more end-users diversify their energy mix in response to, amongst others; the power shortfalls and increasing electricity price¹⁵. LPG has been identified as an alternative energy carrier for the provision of quick and effective solutions to energy requirements. This has made it increasingly important for regulators not only to ensure that there is adequate supply to meet the growing demand, but also that there is a growing need to ensure that this sector is adequately managed and that the issues pertaining to safety regulations, accessibility, price regulations and competitiveness are prioritised.

4. RATIONALE FOR THE MARKET INQUIRY

4.1. Structural features of the market

LPG is manufactured by the oil companies in refineries as a by-product of the process of producing fuel. There are currently 6 refineries in South Africa, however only 2 of these firms are vertically integrated into the market for distribution of LPG – only 2 oil companies are also major resellers.

Afrox, the largest MR in South Africa is not vertically integrated. Afrox purchases its LPG supply from the refineries and also imports a limited amount. The supply of LPG in South

Africa is not adequate to meet demand and this creates room for limited imports into the country.

The limited domestic supply is a concern for several reasons:

- Limited supply of LPG may create circumstances which may foster anti-competitive conduct by the firms involved. The fact that LPG is limited in supply is likely to confer substantial market power to the major resellers that are able to secure supply (allocation) of LPG from the refineries. The wholesale level is not regulated as indicated in figure 1 and discussed above.
- The strategic importance of being able to secure LPG can also be seen in the emergence of firms referred to as 'brokers' which are firms that trade in LPG refinery allocations.
- LPG is currently imported at very limited quantities, this suggests that imports are not providing a competitive constraint to the LPG supplied by the refineries and distributed by the resellers.

4.2. High switching costs

The LPG sector may be characterised by high switching costs, particularly for commercial and industrial customers. This may be in part due to the uncertainty that surrounds the current sourcing practises in the market when customers first make the decision to: a) use LPG as a source of energy and b) choose a particular firm to supply the customer with LPG. LPG supply for commercial and industrial customers is mainly done through the use of a bulk LPG tank distributing LPG to various points around the facility through a complex reticulation system. In most instances, this reticulation system is provided by the chosen supplier of LPG on the understanding that the supply will have exclusive rights to supply LPG for the customer.

The difficulty appears to arise at a later stage if a customer seeks to make the decision to switch to another supplier. It appears unclear who ownership of the reticulation system should cede to. This is exasperated by the fact that these complex systems are generally built into walls at the customer's premises, this means the option does not always exist to replace the system.¹⁶ There appears to be uncertainty when consideration is made of the safety aspect of the ownership and operation of reticulation systems. The uncertainty that surrounds reticulation systems when customers seek to switch to alternative suppliers of

LPG may create a restriction to competition in the market, by artificially raising switching costs. It is also likely that this may create barriers to entry and expansion for smaller distributors who do not have the benefit of a first-mover advantage.

4.3. The regulatory environment

There is price regulation at the refinery level of the market (MGRP) and also at the retail level (cylinders) however the wholesale price of LPG is not regulated. The lack of regulation at this level of the market is likely to confer significant pricing power on the firms active at this level of the value chain; this is particularly so when one also considers the limited supply of LPG in South Africa.

The current regulatory environment does not encourage switching between major resellers which may serve to inhibit competition at that level of the value chain. The current safety regulation framework appears to favour the continued ownership of reticulation systems used by customers by resellers. By conflating the safe use of a reticulation system with its ownership, the regulatory framework may have served to increase switching costs between resellers of LPG, particularly for industrial and commercial customers.

4.4. LPG as a strategic energy source

The government through the National Development Plan and National Growth Path has identified LPG as being of strategic importance in an economy struggling with rising energy prices and an electricity supply under severe pressure. LPG has been identified as an alternative energy carrier of choice for household thermal needs. This is even more so when considering the increasing price and limited supply of traditional energy sources such as electricity which may serve to make them inaccessible for low-income households.¹⁷ LPG can therefore provide low-income households with an affordable alternative energy source; this will relieve them of the financial burden created by rising electricity supply and also serve to relieve some of the pressure on the electricity grid.

LPG is currently underutilised in South Africa as an energy source; only 3% of households in South Africa use LPG as their main energy source for cooking.¹⁸ The limited and the

relatively high price of LPG may serve to keep its usage low.¹⁹ The market for LPG supply and distribution is unlikely to facilitate the usage expansion envisaged by the government with the aim of achieving the energy mix alluded to in the National Development Plan.²⁰ In order for South Africa to meet its strategic objectives as far as sustainable energy is concerned, it is important that the LPG sector is functioning effectively with consideration given to how competition principles can shape efficient market outcomes which will benefit the economy in general but also low-income households in particular.

5. PURPOSE AND OBJECTIVES OF THE MARKET INQUIRY

The **purpose** of the market inquiry is:

- To examine whether there are features of the market which lessen, prevent or distort competition.
- To establish a factual basis for making recommendations to the relevant stakeholders on the state of competition in the sector and also the recommended course of action.

The main **objectives** of the market inquiry are to:

- To examine whether the supply bottlenecks in the LPG industry in South Africa may serve to create circumstances or incentives that serve to distort, prevent or lessen competition.
- To analyse the current price regulatory framework with the aim of examining whether there is room for improving regulation to limit the exercise of substantial market power by market participants.
- To examine whether the current features of the market increase switching costs to a prohibitive level when customers seek to switch between resellers of LPG.
- To assess the extent of the barriers to entry and general competition dynamics at various levels of the value chain.
- To make recommendations that may serve to improve the state of competition.
- To make recommendations on appropriate policy and regulatory mechanisms that would enhance competition. This, where possible, will be achieved through:
 - Reviewing international models for regulatory interventions
 - Engaging with different regulators and stakeholders to obtain their input
 - Identifying possible regulatory models/ options for South Africa

- To make recommendations with regard to the role of competition policy and competition law in achieving pro-competitive outcomes in the LPG sector in South Africa.

6. THE PROPOSED MARKET INQUIRY PROCESS AND TIMELINES

6.1. Market inquiry process

The Commission will evaluate the subject matter of the inquiry through a review of secondary material obtained via information requests, consultations and summons, as required. The Commission will also utilise public hearings and targeted interviews if the need arises. All interested and affected parties will be invited to submit information to the Commission which is relevant to the subject matter of the inquiry. The inquiry will be carried out by a team of the Commission's staff.

The participants in the market inquiry process will include: business enterprises along the LPG value chain (including manufacturers, wholesalers/distributors and retailers), other related business enterprises, end-users, government departments, public entities, regulatory authorities, industry associations, and any other stakeholders that may be able to provide information relevant to the market inquiry. Members of the public will be invited to participate in the inquiry during the information gathering phase and during the public hearings. Members of the public are encouraged to participate fully in the inquiry process.

The Commission is committed to the principles of fairness, transparency, and integrity and will conduct the inquiry in accordance with these principles. The Commission will allow stakeholders fair and reasonable opportunity to provide input into the inquiry process and its outcomes. Therefore the Commission will take reasonable steps to ensure that interested parties understand the Commission's thinking on the market inquiry as it develops. For this reason and its commitment to transparency, the Commission may release "issues statements" or interim reports throughout the market inquiry for public consideration and comment. The Commission may also release a report at the conclusion of the market inquiry.

The market inquiry will be carried out in three phases.²¹ These are detailed below:

6.2. Timelines

The market inquiry is expected to commence in June 2014 and is likely to be completed by October 2015. Several of the steps highlighted below may overlap which could expedite the process.



The exemption application was filed under Schedule 1 Part A read with Part B of the Competition Act.

The exemption application is based on the premise that the IDOW rules are (i) necessary to maintain professional standards or the ordinary function of the profession in terms of Schedule 1, Part A of the Competition Act and (ii) provided for in the Built Environment legislative framework. In particular, the CBE relies on section 4(q) of the CBE Act, which gives it the responsibility to liaise with the Commission on behalf of the professional councils regarding the development and implementation of the IDOW rules.

In terms of Schedule 1 Part A (2) of the Competition Act:

"The Competition Commission may exempt all or part of the rules of a professional association from the provisions of Part A of Chapter 2 of the Competition Act for a specified period if, having regard to internationally applied norms, any restriction contained in those rules that has the effect of

substantially preventing or lessening competition in a market is reasonably required to maintain-

- (a) *professional standards; or*
- (b) *the ordinary function of the profession."*

- In the year 2008, the applicant employed 500 people in its Johannesburg and Durban branches. However, due to low priced imports and losing customers, the Durban branch had to be closed. This resulted in retrenchments of 250 employees. The employment numbers have since been further reduced to 145 due to the company's inability to compete with low priced imports.

NOTICE 449 OF 2014**INTERNATIONAL TRADE ADMINISTRATION COMMISSION****NOTICE OF INITIATION OF AN INVESTIGATION INTO THE ALLEGED DUMPING OF WHEELBARROWS ORIGINATING IN OR IMPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA (CHINA)**

The International Trade Administration Commission of South Africa (the Commission) accepted an application alleging that wheelbarrows originating in or imported from the People's Republic of China (China) is being dumped on the South African Customs Union (SACU) and causing material injury to the SACU industry concerned. The Applicant submitted sufficient evidence and established a *prima facie* case to enable the Commission to arrive at a reasonable conclusion that an investigation should be initiated on the basis of dumping, material injury and causality.

THE APPLICANT

The application was lodged by Lasher Tools.

THE PRODUCT

The product allegedly being dumped is wheelbarrows, classifiable under tariff subheading 8716.80.10, originating in or imported from China.

THE ALLEGATION OF DUMPING: PEOPLE'S REPUBLIC OF CHINA (CHINA)

The allegation of dumping is based on the comparison between the normal value and the export price. The Applicant was unable to obtain a domestic selling price in China. Therefore, in terms of the provisions of the Record of Understanding, the Applicant nominated Zimbabwe as an appropriate third country to determine the normal value and obtained the cooperation of a manufacturer in Zimbabwe. The normal value for China was therefore based on a quotation provided by the cooperating manufacturer in Zimbabwe. The export price for China was determined based on the official South African Revenue Service (SARS) statistics. An adjustment for transport was made to the f.o.b. import price to calculate the ex-factory export price. The dumping margin for China was determined to be 505.33%.

On this basis, the Commission found that there was a *prima facie* proof of dumping.

THE ALLEGATION OF MATERIAL INJURY AND CAUSAL LINK

The Applicant submitted evidence to show that it is experiencing price undercutting and price suppression. The Applicant also submitted evidence indicating a decline in market share and profit. It further submitted information to indicate a decline in growth and inability to raise capital investment.

On this basis the Commission found that there was *prima facie* proof of material injury and causal link.

PERIOD OF INVESTIGATION

The period of investigation for purposes of determining the dumping in the exporting country of origin will be from 1 February 2013 to 31 January 2014. The period of investigation for purposes of determining material injury will be from 1 July 2010 to 31 January 2014.

PROCEDURAL FRAMEWORK

Having decided that there is sufficient evidence and a *prima facie* case to justify the initiation of an investigation, the Commission has begun an investigation in terms of section 16 of the International Trade Administration Act, 2002 (the ITA Act). The Commission will conduct its investigation in accordance with the relevant sections of the ITA Act and the Commission's Anti-Dumping Regulations (ADR). Both the ITA Act and the ADR are available on the Commission's website (www.itac.org.za) or from the Trade Remedies section, on request.

In order to obtain the information it deems necessary for its investigation, the Commission will send non-confidential version of the application and questionnaires to all known importers and exporters, and known representative associations. The trade representative of the exporting country has also been notified. Importers and other interested parties are invited to contact the Commission as soon as possible in order to determine whether they have been listed and were furnished with the relevant documentation. If not, they should immediately ensure that they are sent copies. The questionnaire has to be completed and any other representations must be made within the time limit set out below.



1. Definitions

In these Rules "**the Act**" means the Collective Investment Schemes Control Act, 2002 (Act No. 45 of 2002), and any word or expression to which a meaning has been assigned in the Act bears the meaning so assigned to it and, unless the context otherwise indicates –

"deposit" means a deposit as defined in the Banks Act, 1990 (Act No. 94 of 1990), or in the Mutual Banks Act, 1990 (Act No. 124 of 1993);

"non-reducible participation bond" means a participation bond, other than a reducible participation bond, whose conditions regarding the repayment of the capital and the payment of interest are agreed between the manager and the mortgagor, from time to time;

"reducible participation bond" means –

- (a) a participation bond which provides for the redemption by regular annual payments, or payments at shorter intervals, of the capital amount advanced and of interest due on the amount outstanding under the bond; and
- (b) a former non-reducible participation bond which after the registration of the participation bond, has been converted by written agreement between the mortgagee and the mortgagor, to a reducible participation bond as contemplated in paragraph (a);

"scheme" means a collective investment scheme in participation bonds as defined in the Act.

2. Valuation of property and screening of borrower

Before granting a loan upon the security of a participation bond, the manager must:-

- (a) take into account the financial standing, and the ability, of the borrower to make repayments of the loan;
- (b) arrange for the immovable property to be hypothecated under the participation bond, to be valued by a person who is independent from the manager and any of the manager's associates and, in the opinion of the manager, who is competent to make such a valuation and who must, in assessing the value of the immovable property, take cognisance of the type of immovable property, its locality, its state of repair, its ability to be sold and its income producing potential; and
- (c) ensure that a documented risk management programme is in place in order to assess the value of the property. The risk management programme must stipulate that an assessment of the property is to be conducted at least once in every three years.

3. Approval of loans

(1) The Board of Directors of the manager (who may delegate this function to a committee or other suitable person) must approve all loans granted upon the security of a participation bond.

(2) The manager may not apply funds received for investment in a collective investment scheme in participation bonds for the granting of loans against security of immovable property in which:–

- (a) the manager or any of its associated companies; or
- (b) shareholders, directors or employees of the manager and any of its associated companies

has a direct or indirect interest.

4. Maximum amount of bond

(1) If a bond is a reducible mortgage bond then, subject to rule 5, no more than seventy-five percent of the value of the immovable property mortgaged or to be mortgaged under a participation bond, determined in terms of rule 2(b), may be advanced by the manager upon the security of such bond.

(2) If a bond is a non-reducible mortgage bond then, subject to rule 5, no more than sixty seven percent of the value of the immovable property mortgaged or to be mortgaged under a participation bond, determined in terms of rule 2(b), may be advanced by the manager upon the security of such bond.

(3) If there is a *pari passu* ranking charge over the immovable property mortgaged or to be mortgaged under such participation bond, the maximum amounts which may be advanced by the manager as aforesaid, must be reduced by the maximum possible indebtedness secured under the *pari passu* ranking charge.

5. Maximum amount of bond: collateral security

(1) Where the manager accepts collateral security for the debt secured under a participation bond in the form of a surety or a collateral mortgage bond ranking as first mortgages over immovable property and registered or endorsed as a participation bond, rule 4 applies to such collateral security and the manager may advance:—

- (a) in the case of a reducible participation bond, an amount not exceeding seventy-five percent; or
- (b) in the case of a non-reducible participation bond, an amount not exceeding sixty seven percent,

of the aggregate value of the immovable property mortgaged under such participation bond and the immovable property mortgaged under such surety or collateral mortgage bond, as the case may be.

(2) Where there is a *pari passu* ranking charge over the immovable property mortgaged or to be mortgaged under such surety or collateral mortgage bond, the maximum amounts as aforesaid which may be advanced by the manager must be reduced by the maximum possible indebtedness secured under such *pari passu* ranking charges.

6. Valuation, maintenance and inspection of property

The manager must ensure that:—

- (a) every immovable property which is subject to a mortgage bond, is valued:
 - (i) at least once in every five years by the person described in rule 2(b); and
 - (ii) whenever a loan is three months in arrears; or
 - (iii) when additional amounts are advanced to a borrower; or
 - (iv) at any other time, should the manager be of the view that the value of the immovable property may be affected;
- (b) every participation bond and every surety or collateral mortgage bond, accepted by the manager as collateral security, includes a condition that the mortgagor concerned must keep the mortgaged immovable property in good order and repair and the manager must, at least once in every five years, inspect or cause every such immovable property to be inspected in order to ensure that such condition is complied with;
- (c) a documented risk management programme contemplated in rule 2(c) is in place;
- (d) the ratios of values against advances stipulated in rule 4 are maintained when the immovable property in question is valued every five years as contemplated in sub-rule (a); and
- (e) any deviation from these ratios is reported to the registrar immediately.

7. Insurance of property

The manager must take reasonable care to ensure that:–

- (a) every immovable property mortgaged under a participation bond is adequately insured by the mortgagor concerned with a short-term insurer authorised to carry on insurance business within the Republic of South Africa against the risks of fire, storm and tempest and such other risks and contingencies as the manager may from time to time consider necessary; and
- (b) the policy of insurance is ceded to the nominee company.

8. Safe custody of documentation

All documentation in respect of participation bonds and all other securities registered in the name of, ceded, pledged or delivered, to the nominee company for the purposes of the scheme, must, except when in the temporary custody of others for the purposes of the scheme, be kept in safe custody in the safes or strong-rooms of the manager or with a bank approved by the manager.

9. Offer of participatory interests

A manager may not offer, grant or hold participatory interests in a scheme, whose aggregate value exceeds the balance of the principal debt owing under all participation bonds and other permissible assets included in the scheme.

10. Disclosure of information in application form

An application form used by an investor to invest in a collective investment scheme in participation bonds must disclose at least the following information, in addition to the information contemplated in section 3 of the Act, to the extent that the information is applicable to collective investment schemes in participation bonds:-

- (a) that money invested in the scheme must remain invested in such scheme for a period of not less than five years;
- (b) that the participant's investment is secured by all the participation bonds included in the scheme and that the debt owing under such bonds is, to the extent of the participatory interest granted to such participant, a debt owing to such participant and not to the manager or the nominee company;
- (c) that neither the manager nor the nominee company guarantees the repayment of the debt;
- (d) that, upon the expiry of the five year period referred to in section 58 of the Act, the participant may withdraw his or her investment, subject to rule 22(2) and subject to the participant having given the manager written notice;

- (e) the period of the written notice referred to in rule 22(2)(b), which period shall not be more than three months;
- (f) that the participant may, within the five year period referred to in section 58 of the Act, transfer, cede or encumber his participatory interest, subject to rule 22(1);
- (g) that the interest payable by the mortgagors under participation bonds may fluctuate during the terms of such bonds and that interest payable to the participant may fluctuate;
- (h) that interest paid by mortgagors to the manager in terms of participation bonds, less the manager's administration fees, which must be determined by the manager from time to time, must be paid by the manager to the participants at intervals determined by the manager;
- (i) that the manager must, at intervals of no more than three months, furnish each participant, in writing or by electronic means, with a statement of account disclosing the amount of capital owing to the participant and indicating how the net amount of interest paid has been calculated;
- (j) such further information as the registrar may require.

11. Receipt of funds for investment in a scheme

- (a) Any money accepted or received by the manager from any person for investment in a scheme, must be kept by the manager on deposit, or in a money market portfolio of a collective investment scheme in securities, in the name of the nominee company on behalf of the person from whom it was accepted or received and such money must remain so invested until such person is granted a participatory interest in such scheme or until the money is repaid to such person.
- (b) If a participatory interest is not granted to a person referred to at sub-paragraph (a) within 60 days from the date of acceptance or

receipt of such money by the manager, or within such further period as the registrar may allow in a particular case, the manager must immediately refund such money to such person.

12. Funds received in reduction of principal debt

Any money received by the manager in reduction of the principal debt owing under a participation bond included in a scheme must be kept on deposit by the manager in the name of the nominee company on behalf of all the participants in the scheme until the money is:-

- (a) re-invested by the manager in another participation bond or bonds included in the scheme; or
- (b) repaid to the participants in the scheme: Provided that the money may not be repaid to any participant, or his successor, until the expiry of the five year period referred to in section 58 of the Act.

13. Registers to be kept by manager

(1) The manager must keep a Register of Bonds and a Register of Participatory Interests, which must include the following information:-

- (a) Register of Bonds
 - (i) particulars of all participation bonds included in the scheme;
 - (ii) the balances owing under the bonds from time to time;
 - (iii) the names of the mortgagors; and
 - (iv) a description of the properties so bonded.
- (b) Register of Participatory Interests
 - (i) the names of participants in the scheme;
 - (ii) the extent of their participatory interests from time to time; and
 - (iii) the date of each investment by such participants.

(2) The register of bonds must be available for inspection by any person with a legitimate interest in the information, free of charge, at the registered office of the manager during the normal business hours of the manager.

(3) The register of participatory interests must be available for inspection by the registrar or any person with a legitimate interest in the information.

14. Power of manager to exercise and enforce rights of participants under participation bonds

(1) The manager may in its discretion, but subject to the provisions of sections 4(1) and 4(2) of the Act, exercise and enforce through and in the name of the nominee company, on behalf of the participants, any or all of the rights of the participants under any participation bond included in such scheme and, without affecting the generality of the foregoing, may:—

- (a) grant any consent in any case where the consent of a mortgagee, a legal holder of a bond or a holder of a bond is required in terms of the Deeds Registries Act, 1937 (Act No. 47 of 1937);
- (b) institute any legal proceedings in respect of the participation bond and any security collateral thereto, in particular to recover any amount owing, and sell the immovable property mortgaged under the participation bond and under any security collateral thereto in execution of any judgement obtained;
- (c) grant to the mortgagor under the participation bond extension of time to pay the mortgage debt or interest thereon;
- (d) subject to rules 4 and 5, grant re-advances to the mortgagor under the participation bond or grant any additional advance upon the security of a *pari passu* participation bond, at such rate of interest and upon such terms of repayment as the manager may deem fit;
- (e) agree to change the rate of interest payable under the participation bond and to amend any other conditions thereof; and
- (f) receive notice from or give notice to the mortgagor under the participation bond for the repayment of the whole or any portion of the debt secured under the participation bond.

(2) When an immovable property is sold in execution as contemplated in sub paragraph (1)(b) and the price fetched is not sufficient to cover the amount

outstanding on the participation bond plus the foreclosure costs, the following shall apply:-

- (a) if the manager reasonably believes that the price fetched represents the realistic open market value of the property it:
 - (i) shall not prevent the property from being sold to the highest bidder;
 - (ii) shall deal with the amount realised after deduction of foreclosure costs in terms of Rule 12;
 - (iii) may pursue action against the mortgagor under the participation bond or any other party who may be held liable, for recovery of any loss suffered by the scheme;
- (b) alternatively to (a) if the manager reasonably believes that the price fetched does not represent the realistic open-market value of the immovable property:
 - (i) the manager must buy-in the immovable property and at its cost cause it to be registered in the name of the nominee company;
 - (ii) the nominee company shall hold the immovable property in lieu of the participation bond as nominee for or representative of the participants;
 - (iii) the manager shall receive any income derived from the immovable property and shall bear all expenses, rates and taxes relating to the immovable property;;
 - (iv) the manager shall take care that the property is adequately insured while held by the nominee company, Rule 7 finding application with the necessary changes;
 - (v) the immovable property shall be disposed of as soon as practically feasible, considering the interests of the participants: provided that the holding of the property beyond twelve months will require the Registrar's consent;
 - (vi) the proceeds of the disposal of the immovable property after deduction of

- (aa) any outstanding legal costs consequent upon the foreclosure proceedings and costs of transfer of the immovable property to the nominee company;
- (bb) sales commission payable in respect of the disposal in terms of sub-paragraph (v); and
- (cc) any deficit arising from the holding of the property as envisaged by sub-paragraph (iii);
shall be for the credit of the scheme;
- (vii) any loss arising from the buying in, holding or and disposal of the immovable property shall be dealt with in terms of Rule 17: provided that the manager may pursue action against the former mortgagor under the participation bond for the recovery of any such loss;
- (c) the manager must file financial reports with the registrar on a quarterly basis giving an update on the matters set out in sub-paragraphs (a) or (b), as the case may be, and indicating the manager's plan to safeguard the interests of participants. .

15. Rights of participants: recovery of debts

Notwithstanding rule 14 a participant may, in respect of a participation bond, instruct the manager to take all the necessary steps, through and in the name of the nominee company, to recover from the mortgagor such portion of the principal debt as is necessary to repay, in full, the participatory interest of such participant in such bond: Provided that a participant may only so instruct the manager if the mortgagor has failed to comply with the conditions of the bond.

16. Rights of participants: legal proceedings

A participant may not take any action, legal or otherwise, in his or her own name to enforce the rights held by the participant in any participation bond included in a scheme.

17. Duty of participants to refund legal costs not recovered

Where any proceedings are instituted by or through and in the name of the nominee company in respect of a participation bond included in a scheme, the participants in that scheme may be required to refund to the nominee company, or the manager, as

the case may be, pro rata any of the costs of the proceedings that may not be recovered by the nominee company or the manager from the mortgagor.

18. Assets of nominee company not included in a scheme

The rights of a participant in the participation bonds included in a scheme are limited to his or her rights in respect of the bonds and any collateral security relating thereto and do not extend to other property or securities registered in the name of the nominee company or to any other assets of the nominee company not included in the scheme.

19. Distribution of funds received in reduction of principal debt

(1) Subject to sub-rule (2), the manager is not be obliged to distribute any payment made in reduction of the principal debt owing by a mortgagor under a particular participation bond amongst all the participants in the scheme proportionate to their participatory interests in the scheme, but may in its sole discretion allocate such payment to any one or more of the participants.

(2) Any payment received by the manager as a result of legal proceedings taken against the mortgagor under a participation bond for the recovery of the amount due under such bond or a payment which:-

- (a) represents a dividend received from the trustee, executor, liquidator or business rescue practitioner of the mortgagor, or
- (b) is a payment received in terms of a compromise between the mortgagor and his creditors,

is the property of the participants in the scheme in which such bond is included to the extent of their respective participatory interests and must be allocated by the manager to the said participants proportionately to the extent of their participatory interests in the scheme.

(3) The manager must, subject to rule 12, immediately credit the proceeds of any participation bond repaid, whether in whole or in part, and any payment allocated in terms of sub-rule (1) or (2) to the account of the participant entitled to the payment and must thereafter deal with such payments in accordance with the instructions of such participant.

20. Payment of interest to participants

Every participation bond must provide that the mortgagor must pay interest on the principal debt secured by such bond to the manager as agreed upon by the manager and mortgagor. Such interest, less the manager's administration fee and such other fees and charges as imposed and determined by the manager from time to time must within thirty days after the date on which interest payments have been received from the mortgagor, be paid by the manager to participants.

21. Statements of account

The manager must furnish, in writing or by electronic means, each participant with a statement of account, at intervals of no more than three months, disclosing the amount of capital owing to the participant concerned and indicating how the net amount of interest paid has been calculated.

22. Cession, transfer or encumbering of participatory interest and withdrawal of investment

(1) A participant may transfer, cede or encumber part or the whole of his or her participatory interest without the consent of any of the mortgagors concerned provided that:–

- (a) the manager is not obliged to note a cession, transfer or encumbrance unless informed in writing thereof and the fees and charges as may be determined by the manager have been paid by such participant or his or her successor;
- (b) a cession, transfer or encumbrance is only enforceable against the manager if the manager has confirmed in writing that the cession, transfer or encumbrance has been noted and that the fees and charges referred to in sub-paragraph (a) have been paid in full; and
- (c) the manager may refuse to note such cession, transfer or encumbrance if the participatory interest is ceded or transferred to, or encumbered in favour of, more than one person with the result that the extent of any participatory interest held by a person is less than

the minimum investment determined by the manager from time to time.

(2) A participant may, upon the expiry of the five year period referred to in section 58 of the Act, withdraw part or the whole of the funds invested by him or her in a scheme, if:-

- (a) the manager has consented to the withdrawal, which consent may not be unreasonably withheld, provided that where the manager withholds consent, the manager must provide reasons in writing for withholding the consent;
- (b) the participant has given the manager written notice, the period of which must be determined by the manager and disclosed in the application form, of his or her intention to withdraw such investment; and
- (c) the participant has paid such reasonable fees and charges as the manager may impose.

23. Insurance

The manager must hold adequate insurance against losses resulting from the negligence, dishonesty or fraud of all persons (including valuers and directors) engaged by the manager and the nominee company for the purpose of the scheme.

24. Appointment of new manager

The manager may, on not less than six months written notice to the registrar and all participants in the scheme, appoint a new manager, subject to:-

- (a) the consent of the registrar and the participants holding a majority in value of the participatory interests in all participation bonds included in the scheme. If the participants holding a majority in value of the participatory interests in all participation bonds do not indicate their consent in writing on or before the date determined, then the registrar's consent to the appointment of a new manager will suffice; and

- (b) the new manager entering into an agreement with the nominee company in terms of paragraph (c) of the definition of "nominee company" in section 52 of the Act.

25. Termination of scheme

The manager may terminate the scheme at any time provided that not less than six months written notice must be given to all participants and to the registrar, specifying the date of such termination. From the date of such written notice the manager may not accept monies for investment in participation bonds in the scheme to be terminated.

26. Duty of manager upon termination of scheme

Upon the termination of the scheme, the manager must:-

- (a) subject to their respective terms and conditions, call in all participation bonds included in such scheme and pay out participants to the extent of their participatory interest provided that, with the consent of the registrar and all participants, the manager may cause the nominee company to cede any such bond, or all such bonds, to the participants to the extent of their respective rights to and interest in such bond or all such bonds; and
- (b) withdraw all deposits and pay out the money so withdrawn to the participants entitled thereto.

27. Amalgamation and cession of rights or take-over of nominee

company

- (1) Despite these rules the manager may, after having obtained the written consent of the registrar, authorise the nominee company to:-
 - (a) amalgamate with; or
 - (b) cede any rights of the said nominee company under any participation bond registered in its name to; or
 - (c) take over any rights under any participation bond from, any other nominee company, which has been approved by the registrar.

(2) The manager and the nominee companies which are parties to an amalgamation, cession, transfer or take-over in terms of sub-rule (1) must ensure that:—

- (a) any surety mortgage bond, collateral security or any cash pertaining to a participation bond which is ceded or transferred, is ceded or transferred with the participation bond concerned to the nominee company taking over the rights under such participation bond in order to vest in such nominee company the rights and obligations referred to in the Act; and
- (b) in the case of an amalgamation, or in the case of a cession of the rights under all the participation bonds included in a scheme, any cash is transferred to the nominee company taking over the rights under such participation bonds, in order to vest in such nominee company the rights and obligations referred to in the Act.

28. Notices

(1) Any notice, statement of account or other document required to be served on a participant shall be deemed to have been duly served if sent by post to or delivered at his or her address as stated on the application form, or at such other address as notified in writing by the participant to the manager from time to time, and be deemed to have been served four days after the same was posted or delivered. In proving such service it shall be sufficient to prove that the envelope or wrapper containing the notice was posted.

(2) Any notice sent to a participant by means of a facsimile shall be deemed to have been served on the date of facsimile transmission.

(3) Any notice may be sent electronically if so requested by a participant, and shall be deemed to have been served on the same day it was sent.

(4) Any notice or document sent by post to or delivered at the participant's address referred to in sub-rule (1), sent per facsimile in terms of sub-rule (2) or sent electronically in terms of sub-rule (3) shall, notwithstanding that such participant is deceased, insolvent, or under any other legal disability, and whether

or not the manager has notice of his or her death, insolvency or other disability, be deemed to have been duly served, and such service shall be deemed a sufficient service on all persons who have an interest in the participatory interests of the participant concerned.

(5) The unintended omission to give notice to a participant, or the non-receipt of any notice by any participant, does not give rise to any claim by such participant against the scheme or the manager, and does not invalidate anything done pursuant to or in terms of such notice.

29. Electronic and telephonic transacting

(1) The manager may allow for transacting via electronic and telephonic means, subject to sub-rules (2) and (3) and the consent of the participant or a prospective participant.

(2) If the participant consents to electronic or telephonic transacting, the participant must be fully apprised in the initial application form used for electronic and telephonic transacting and in all application forms posted on the manager's website, of the conditions of electronic and telephonic transacting.

(3) Such application forms must at least provide for -

- (a) the procedure to effect electronic or telephonic transacting and the costs involved;
- (b) the procedure for registration of an electronic or telephonic transaction;
- (c) the legal implications of such a transaction for the participant;
- (d) all disclaimers by the manager;
- (e) any limitation of liability afforded to the manager;
- (f) the security risks and risk of interception inherent to electronic and telephonic transacting;
- (g) related precautionary or security measures;

- (h) confirmation to participants that telephone calls are recorded and that such records are retained for a period of five years;
- (i) confirmation by the manager that its website complies with relevant legislative requirements applicable in the Republic;
- (j) a warning that taxation of other jurisdictions is not taken into account;
- (k) a warning that information contained on the website does not constitute advice.

(4) The terms and conditions under which electronic or telephonic transacting is done must be displayed on screen or verbally communicated, as the case may be.

30. Rules are binding

These rules are binding on the manager, the nominee company, participants and their successors in title.

31. Repeal and commencement

- (1) Notice GN 577 of 28 February 2003 as published in *Government Gazette 24984* is hereby repealed.
- (2) This Notice comes into effect on 1 July 2014.

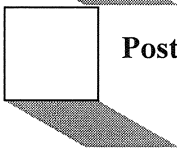
Poster of Basic Conditions of Employment Act (Summary)

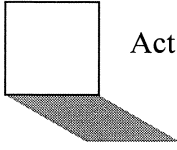


Poster of Employment Equity Act (Summary)
