AND ONE SUCCULENT PLANT GENUS IN APPENDIX III OF THE CONVENTION ON

I, Barbara Dallas Creecy, Minister of Forestry, Fisheries and the Environment, hereby, under section 99 and 100 of the National Environmental Management: Biodiversity Act, 2004 (Act No. 10 of 2004), give notice of my intention to submit to the Secretariat of the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES), a notice for the inclusion or listing of seventeen succulent plant species and one succulent plant genus in Appendix III of CITES, as indicated in the Schedule hereto.

Members of the public are invited to submit to the Minister, within 30 days from the date of the publication of this notice in the *Government Gazette*, written representations and objections to the inclusion or listing of the succulents in Appendix III of CITES to the following addresses:
