**PURSUANT TO THE CONSIDERATION OF THE REQUEST FOR THE EXTENSION OF THE CLOSING DATE FOR RECEIVING THE PUBLIC REPRESENTATIONS AGAINST THE INFORMATION MEMORANDUM PUBLISHED IN THE GOVERNMENT GAZETTE NO. 46738 ON 17 AUGUST 2022, THE INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA HEREBY PUBLISHES A NOTICE REGARDING THE AMENDMENT OF THE CLOSING DATE FOR PUBLIC REPRESENTATIONS ON THE INFORMATION MEMORANDUM**

1. On 17 August 2022, the Independent Communications Authority of South Africa (“the Authority”) published the Notice regarding the Information Memorandum, intending to initiate the second phase of the licensing process with respect to availing radio frequency spectrum to prospective licensees to provide wireless mobile broadband access services in the low and mid radio frequency bands.
2. The Authority considered various requests to extend the closing date of receiving the representations from the public and decided as follows:
  - 2.1. The Authority hereby amends the closing date of public representations on the Information Memorandum to 30 September 2022.
  - 2.2. Interested persons are therefore required submit written representations to the Authority, including an electronic version of the representations in Microsoft Word by no later than 16h00 pm (SAST) on **30 September 2022**.
  - 2.3. No further extension shall be granted.
3. All other contents in the IM Notice remain unchanged.
