I, Barbara Dallas Creecy, Minister of Forestry, Fisheries and the Environment, acting in terms of section 14(2), read with section 14(4) of the World Heritage Convention Act, 1999 (Act No. 49 of 1999), hereby give notice of my intention to appoint suitable persons as Board members of the iSimangaliso Wetland Park Authority (IWPA). The term of appointment of the current Board members of the IWPA will expire on 28 February 2023.

Members of the public are invited to submit written nominations of suitable persons to be considered for appointment within two weeks from the date of publication of this notice in the Gazette, or in the newspapers, whichever date is the last date.

Nominations must be accompanied by an acceptance letter from the nominee as well as the Curriculum Vitae of the person or persons being nominated. The nomination must, at a minimum, include the following:

- (a) personal details, including full names, surname, race, gender and disability of the nominee;

- (c) certified copies of both academic qualifications and identity document;
- (d) experience with reference to the criteria contained in section 14(4) of the World Heritage Convention Act, 1999 (Act No. 49 of 1999); and
- (e) other relevant information.
