## PROCLAMATION NOTICE 73 OF 2022

**DETERMINATION OF SALARIES AND ALLOWANCES OF TRADITIONAL LEADERS,  
MEMBERS OF NATIONAL HOUSE AND PROVINCIAL HOUSES OF TRADITIONAL  
LEADERS**

1. In terms of section 5(1) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998) (hereafter referred to as ("the Act"), I hereby determine that the salaries and allowances of the positions of office bearers in Column 3 of Schedule shall be as set out in Column 4 of Schedule with effect from 1 April 2021, subject to the provisions of section 5(2) and (4) of the Act, and the terms and conditions set out herein.
