**NOMINATION OF CANDIDATES FOR APPOINTMENT ON THE BOARD OF DIRECTORS OF THE LAND BANK IN TERMS OF THE LAND AND AGRICULTURAL DEVELOPMENT BANK (LAND BANK) ACT, 2002 (ACT No. 15 OF 2002)**

In terms of Section 4(1) of the abovementioned Act, the Minister of Finance appoints Directors to the Board of the Land Bank to manage the business of the Bank.

Members of the Board are appointed for a term of office determined by the Minister but not exceeding five years.

The Minister of Finance hereby invites persons and stakeholders to submit to him the names and curricula vitae of persons with a background in **Asset and Liability Management, and Corporate Finance** to be considered for appointment on the Board of Directors of the Land Bank.

A written acceptance by the nominee in the form of a letter must accompany each nomination, and each nominee must also certify that he or she is not disqualified to serve as a member of the Board as determined by Section 10 of the Land Bank Act, 2002.

Furthermore, the nomination should include curriculum vitae of the nominee, providing the following information: full name; identity number and gender; latest address; contact number and email; previous experience quoting dates and organisations or institutions concerned; academic qualifications and other directorships; certified copy of the identity document and qualifications; and any other information that may be of assistance to the National Treasury in making recommendations.

The Minister of Finance determines the remuneration allowances and other benefits of the Chairperson and other Board members.

The National Treasury reserves the right to amend, modify or withdraw this advert or to amend, modify or terminate any of the requirements set out herein at any time and from time to time, without prior notice and without liability to compensate or reimburse any party and to appoint candidates based on amongst others, qualifications, skills/experiences and fit for purpose. Therefore, if nominees are not contacted upon finalization of the appointment process, they should consider their nomination unsuccessful.
