**PROPOSED PROCLAMATION : UPGRADING, WIDENING, DEVIATION  
AND CLOSURE OF PORTION OF PROVINCIAL MAIN ROAD 460 COEGA,  
DISTRICT OF PORT ELIZABETH ("MR460")**

**TO ALL INTERESTED PARTIES**

1. Take notice that the Member of the Executive Council, Department of Roads and Transport, Eastern Cape Province, has received a report from the Department of Roads and Transport, Eastern Cape Province, recommending the upgrading, widening, deviation and closure of a portion of Provincial Main Road 460 Coega, District of Port Elizabeth ("MR460"). A copy of the report, together with all relevant annexures, can be inspected during office hours at the Department of Roads and Transport, Office of the District Roads Engineer, Struanway, Struandale, Port Elizabeth (Enquiries : Mr Marius Keyser or Mrs Wilna Snyman, at 041-4522073).
2. The MEC is advised that the said road runs through the properties of Offit (Office Enterprises (Pty) Ltd and Offit Farming Enterprises (Pt) Ltd, collectively referred to as "Offit") and the Coega Development Corporation ("the CDC").
3. The MEC is considering issuing a Proclamation, as per the draft Proposed Proclamation hereunder.
4. The properties to which the Proclamation will apply, are erven 217, 224, 257, 268, 275, 276, 277, 279, 287, 288 and 290 : Coega.
5. Properties erven 268, 287 and 288 are owned by Offit, and properties erven 217, 224, 257, 275, 276, 277, 279 and 290 are owned by the CDC.
6. The nature of the Proclamation, being an administrative action, as is contemplated by the Promotion of Administrative Justice Act, 3 of 2000 ("PAJA") is that it will

constitute an act of expropriation of the rights to use the land affected for purposes of a road, as is clear from section 12(1) of the Eastern Cape Roads Act, 3 of 2003 ("the Act").

7. You are requested to submit any objections, criticism, shortcomings, submissions, comments, representations and/or recommendations in relation to the proposed Proclamation, in writing, to the MEC within 30 days hereof.
8. You are entitled to the choice of an official language for the purposes of any written communications. You are also entitled to request, in writing, a translation of any communication in the official language indicated in such request.
9. Please note that any objections, criticism, shortcomings, submissions, comments, representations and/or recommendations received after the closing date set out above may be disregarded by the MEC.
10. Such written objections, criticism, shortcomings, submissions, comments, representations and/or recommendations must be addressed to :

11. The purpose and effect of the Proclamation, if issued, will be that a portion of MR460 will be upgraded, widened, deviated and closed, as per the Sketch Plans annexed to the report of the Department of Roads and Transport which report, as aforesaid, can be inspected at the premises set out in paragraph 1 above. To the extent shown on the Sketch Plans, the existing 40m road reserve on the land will be deviated, widened or closed, which will cause certain areas of the land to no


longer be encroached upon by a Provincial Public Road, and other areas of the land presently not encroached upon by the existing road, to be encroached upon.

12. The MEC believes that the said upgrading, widening, deviation and closure of MR460 will be to Offit's and the CDC's benefit, and for a public purpose and in the public interest.
13. No right of internal appeal against the proposed administrative action exists. Affected parties will, however, be entitled to approach the High Court on review in terms of PAJA should any ground for review present itself.
14. Once the proposed administrative action has been taken (if it is decided to do so) affected parties will in terms of section 5 of PAJA be entitled to request reasons.
15. Parties are advised to acquaint themselves with the said provisions and to consult their legal representatives thereto.
16. Kindly note that if the Proclamation is proceeded with, affected parties will be entitled to claim compensation, more particularly by virtue of section 12 of the Act read with sections 12 and 26 of the Expropriation Act, 63 of 1975, as well as section 25 of the Constitution, 108 of 1996.
17. Your attention is further directed to the provisions of the Act, in particular sections 5, 10 and 12 thereof, and the Expropriation Act, in particular sections 12, 13, 14 and 26 thereof

**NOTICE \_\_\_ OF 2008****PROCLAMATION OF THE UPGRADING, WIDENING, DEVIATION AND CLOSURE OF A PORTION OF PROVINCIAL MAIN ROAD 460, COEGA, DISTRICT OF PORT ELIZABETH ("MR460")**

1. In terms of section 5 of the Eastern Cape Roads Act, 3 of 2003 ("the Act"), the MEC for Roads and Transport, Eastern Cape Province, hereby proclaims that a Provincial Main Road 460 Coega, District of Port Elizabeth, of varying widths, exists on land, as is indicated on the Sketch Plans hereunder, and that the existing section of Provincial Main Road 460 indicated on the Sketch Plans be diverted and closed as indicated thereon. This entails that in some instances Provincial Main Road 460 exists on the properties shown on the Sketch Plans, where previously no Provincial Main Road existed, and that the previous alignment of the Provincial Main Road 460 is closed where it does not co-incide with the alignment hereby proclaimed. It also entails that the existing Provincial Main Road 460 Coega, District of Port Elizabeth, is widened in certain instances.
2. The aforesaid Sketch Plans and relevant documentation are available for inspection during office hours by any interested person at the Office of the District Roads Engineer, Struanway, Struandale, Port Elizabeth (Enquiries : Mr Marius Keyser or Mrs Wilna Snyman, at 041-4522073).

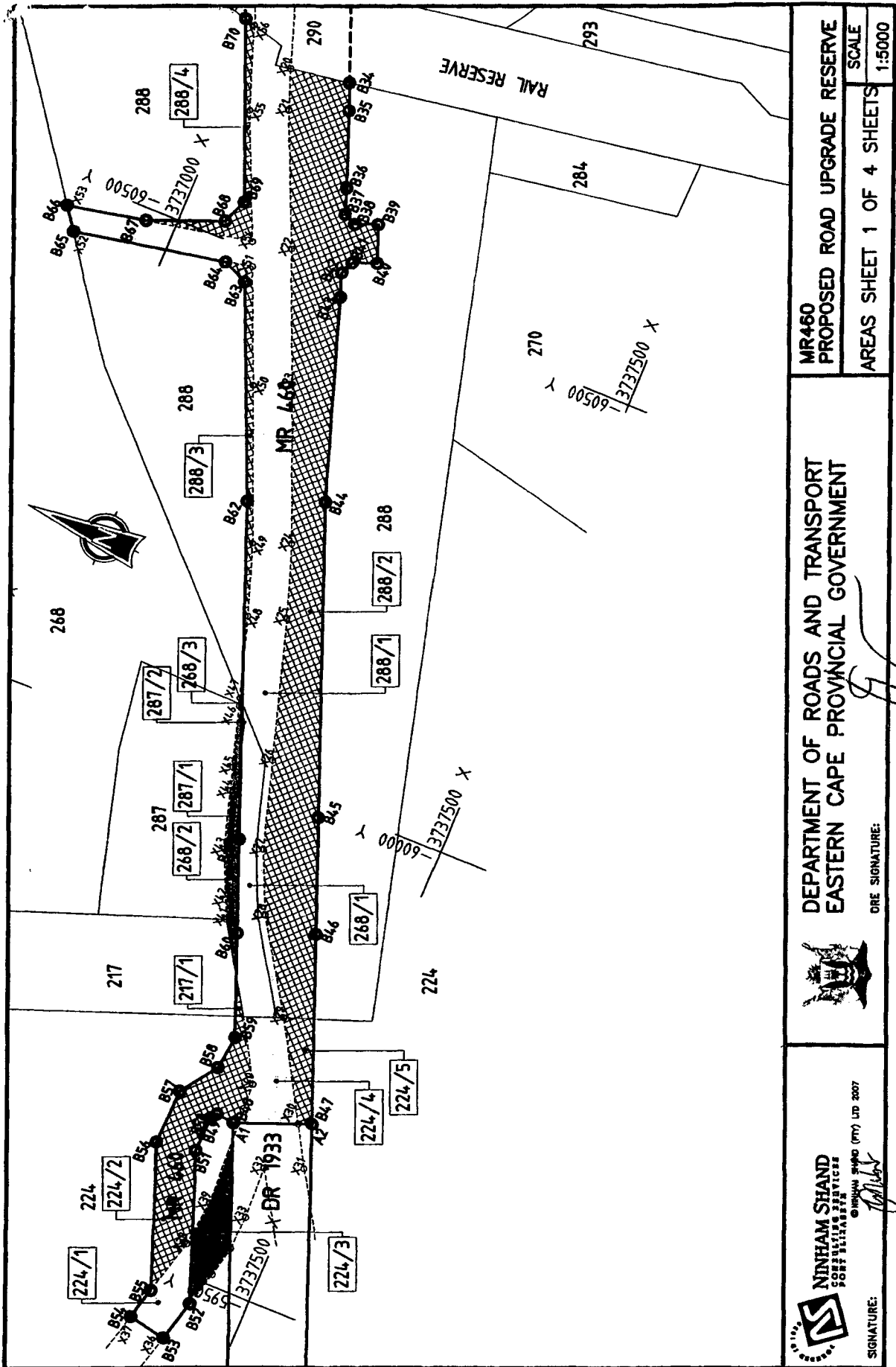

4. You are advised to consult your legal representatives in relation to the Proclamation.
5. The Proclamation takes effect from the date of its publication in the Provincial Gazette.
6. On such date of publication in the Provincial Gazette, or such other date agreed upon, the MEC will take possession of the land and use it for purposes of a Provincial Road in terms of the Act.
7. The MEC is liable to pay compensation for the land encroached upon by the Road, or the widening or deviation thereof in terms of section 12 of the Act, read with sections 12 and 26 of the Expropriation Act, 63 of 1975, as well as section 25 of the Constitution, 108 of 1996.
8. Your attention is drawn in particular to the provisions of sections 8 to 12 and 14 of the Expropriation Act No 63 of 1975.
9. You may request a translation of the Proclamation in the official language of your choice.

6.
