#### **NOTICE OF INTENTION TO EXTEND THE INVITATION DUE DATE FOR NOMINATION OF PERSONS TO SERVE AS MEMBERS OF THE EASTERN CAPE PROVINCIAL ARTS AND CULTURE COUNCIL**

I, Pemmy Majodina, Member of the Executive Council responsible for Sport, Recreation, Arts and Culture in the Province of the Eastern Cape, acting in terms of section 5(1) of the Eastern Cape Provincial Arts and Culture Council Act, 2000 (Act No. 6 of 2000), on 19 September 2014 in Government Gazette No. 3273 (Extraordinary), Notice No. 46 invited nominations from the public, artists, art and culture organisations for the appointment of persons, who will serve as members of the Eastern Cape Provincial Arts and Culture Council.

In terms of the Notice, interested parties were invited to submit nominations by no later than 30 September 2014.

Due to the limited number of nominations received, I deemed it necessary to extend the submission deadline to allow for further nominations. The deadline for nominations is hereby extended to the 16 January 2015.

#### **Nomination and Qualifying Criteria:**

Nominees must have special knowledge or experience in the fields of Arts Administration, Theatre and Performing Arts, Film, Visual Arts and Crafts, Language and Literature, Music and Dance, Living Heritage, Community Arts, Exhibition and Festivals, Campsites, Finance, Business and Financial Management or Law.

Nominees shall be nominated by any member of the public. Nominators are required to submit a detailed motivation of the nominee, curriculum vitae

containing the full names, address, telephone, fax and/or e-mail address of the nominee and a letter acceptance from the nominee.

**Responsibilities:**

- Fulfill the statutory role to advise the Member of the Executive Council on matters pertaining to arts and culture;
- Promoting access and community involvement in arts and culture;
- Promoting the growth of the cultural industry in the province;
- Fostering nation building and social cohesion through the expression of arts and culture.
