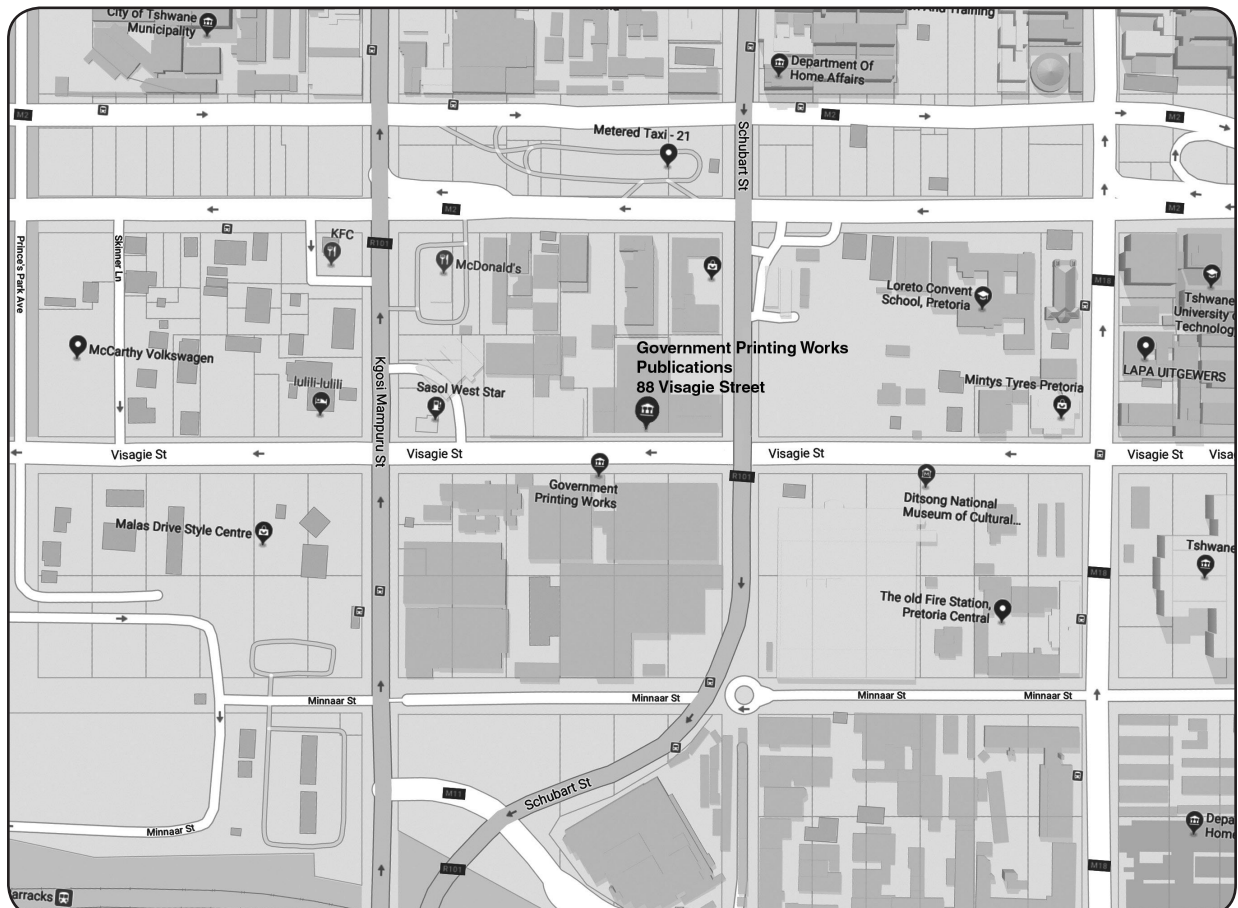

## PROVINCIAL NOTICE 202 OF 2019



### NOTICE OF LODGEMENT OF AN APPLICATION FOR AMENDMENT OF TERMS AND CONDITIONS OF LICENCE IN TERMS OF THE GAMBLING ACT, 1997 (ACT NO. 5 OF 1997) (EASTERN CAPE) (AS AMENDED)

**NOTICE IS HEREBY GIVEN** that an application for amendment of terms and conditions of licence in terms of section 35 of the Gambling Act, 1997 (Act No. 5 of 1997) (Eastern Cape) (as amended), particulars of which are set out in the schedule hereunder, has been lodged with the Eastern Cape Gambling Board.

The application may be inspected by any person at the offices of the Eastern Cape Gambling Board, ECGB Building, Quenera Park, Quenera Drive, Beacon Bay, East London and at the Boardwalk Casino and Entertainment World, 2nd Avenue, Summerstrand, Port Elizabeth, Eastern Cape.

Any objections, petitions or representations shall be lodged with the Chief Executive Officer of the Board within one (1) month of the date of this notice, which commences on **15 July 2019 until 14 August 2019**.

All objections and comments shall specify: the application to which the objection or comment relates; the grounds on which the objection is founded; in the case of comment; full particulars or facts in substantiation thereof: the name, address, telephone and fax number of the objector or person making the comment and a statement whether the objector or person making the comment wishes to make oral representations when the application is heard.

A person lodging representations may show cause why the Board may determine that his or her identity should not be divulged.

The under-mentioned figures used in brackets in Schedules have the following meanings:

- (1) The name and address of the applicant;
- (2) If the applicant is a company or other corporate body, the names of all persons who have a financial or other interest of 5% or more in the applicant;
- (3) In the case of a company the initials and surnames of all directors of the company;
- (4) The type of application applied for; and
- (5) The address of the premises from which the applicant intends to operate from.

**Current condition of licence the Applicant seeks to amend: Clause No.19.9**

Current condition of licence the Applicant seeks to amend: Clause No. 11.1

“11.1 The Casino must consist of

11.1.1 a minimum of 900 (nine hundred) slot machines of which 422 (four hundred and twenty two) shall be situated in the smoking areas of the Casino; and

11.1.2 a minimum of 24 (twenty four) tables of which 10 (ten) shall be situated in the smoking areas of the Casino, provided that, with the prior written approval of the ECGB, the Licensee may provide a further 270 (two hundred and seventy) such slot machines and 7 (seven) such tables at the Casino, and provided further that the ECGB may, on application in writing, permit a different number of slot machines and tables to be provided at the Casino.”

**Proposed amendment to clause No. 11.1**

“11.1 The Casino must consist of

11.1.1 a minimum of 800 (eight hundred) slot machines to be operated within the gaming areas of the Casino; and

11.1.2 a minimum of 24 (twenty four) tables to be operated within the gaming areas of the Casino, provided that, with the prior written approval of the ECGB, the Licensee may provide a further 370 (three hundred and seventy) such slot machines and 7 (seven) such tables at the Casino, and provided further that the ECGB may, on application in writing, permit a different number of slot machines and tables to be provided at the Casino.”

- (5) 2nd Avenue, Summerstrand, Port Elizabeth, Eastern Cape.
