NOTICE OF LODGEMENT OF APPLICATIONS FOR AMENDMENT OF LICENCE CONDITIONS, REMOVAL OF BUSINESS TO OTHER PREMISES AND ACQUISITION OF A FINANCIAL INTEREST IN TERMS OF THE EASTERN CAPE GAMBLING ACT, 1997 (“THE ACT”)

NOTICE IS HEREBY GIVEN that applications for amendment of licence conditions, removal of business to other premises and acquisition of a financial interest in terms of sections 35, 37 and 40 of the Act, particulars of which are set out in the Schedules hereunder, have been lodged with the Eastern Cape Gambling Board.

Any objections, petitions or representations shall be lodged with the Chief Executive Officer of the Board within one (1) month of the date of this notice, which commences on **01 February 2021 until 02 March 2021**.

All objections and comments shall specify: the application to which the objection or comment relates; the grounds on which the objection is founded; in the case of comment; full particulars or facts in substantiation thereof: the name, address, telephone and fax number of the objector or person making the comment and a statement whether the objector or person making the comment wishes to make oral representations when the application is heard.

A person lodging representations may show cause why the Board may determine that his or her identity should not be divulged.

- (2) = If the applicant is a company or other corporate body, the names of all persons who have a financial or other interest of 5% or more in the applicant;
