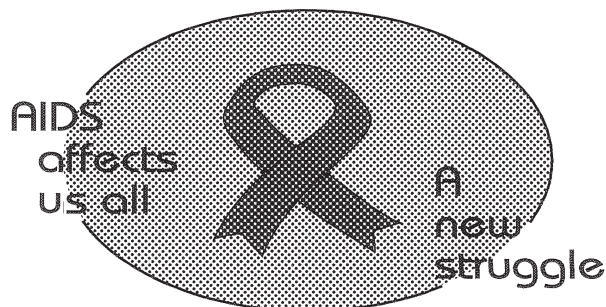

Notice is hereby given that the Draft Request for Proposals in respect of Gambling Machine Site Licences ("the Draft Site RFP") will be available from **Wednesday, 06 April 2022** on the Eastern Cape Gambling Board's website (www.ecgb.org.za) at no cost.

The purpose of the Draft RFP is to invite written comments and suggestions from all interested parties and potential bidders, to highlight the requirements of the RFP, to draw attention to the EMR's, to explain the consequences of non-compliance and to explain the evaluation process. The draft RFP may be amended by the Board after consideration of the aforesaid written submissions and may culminate in the issue of a final RFP.

Please note that the final RFP will constitute the basis of any evaluation for any proposal for the gambling machine site licence and not the Draft RFP. The Draft RFP may substantially change in format and content when it reaches the final RFP stage. Purchase of the Final RFP will be compulsory in respect of each application to be submitted.

Written comments and/or inputs to the Draft RFP clearly marked "Draft RFP" must be submitted **within 30 days from the date of this notice** and sent by email to compliance@ecgb.org.za.
