APPLICATION FOR A GAMING MACHINE LICENSE**

Notice is hereby given that:

- JRF Trading (Pty) Ltd, trading as Queenies Restaurant & Pool Bar, situated at Stand 25, No. 25 Central Avenue, Eastleigh, Edenvale, in the district of Germiston;

Intends submitting an application to the Gauteng Gambling Board for Site Operators License for Limited Payout Machines at the above-mentioned sites.

Attention is directed to the provisions of Section 20 of the Gauteng Gambling Act, 1995, which makes provision for the lodging of written representations in respect of the application.

Written representations should be lodged with the Chief Executive Officer, Gauteng Gambling Board, Private Bag X15, Bramley, 2018, within one month from 12 April 2019.

Such representations shall contain at least the following:

- (a) the name of the applicant to which representations relate;
- (b) the ground or grounds on which representations are made;
- (c) The name, address, telephone and fax number of the person submitting the representations;
- (d) Whether the person submitting the representations requests the board to determine that such person's identity may not be divulged and the grounds for such request; and
- (e) Whether or not they wish to make oral representations at the hearing of the application.
