**APPLICATION FOR AMENDMENT OF LICENSE - SITE RELOCATION & TRADING NAME**

Notice is hereby given that Fundisize (Pty) Ltd T/A G-bets Roodepoort intends submitting an application to the Gauteng Gambling Board for an amendment of its bookmaker licence to:

- Relocate Fundisize (Pty) Ltd t/a Gbets Roodepoort situated at 66 Ontdekkers Road, Westgate, Roodepoort 1734 to Shop S00B3, Westgate Shopping Centre, 120 Ontdekkers Road, Roodepoort 1725.
- To amend its trading name from Fundisize (Pty) Ltd t/a G-Bets Roodepoort to Fundisize (Pty) Ltd t/a G-bets Westgate.

The applications will be available for public inspection viewing on the website of the Gauteng Gambling Board from 03 June 2022. Attention is directed to the provisions of Section 20 of the Gauteng Gambling Act No 4 of 1995 (as amended) which makes provision for the lodging of written representations in respect of the application.

Written representations should be lodged with the Chief Executive Officer, Gauteng Gambling Board, Private Bag 15, Bramley, 2018, within one month from 03 June 2022. Such representation shall contain at least the following:

- (a) The name of the applicant to which the representations relate;
- (b) The ground or grounds on which representations are made;
- (c) The name, address, telephone and fax number of the person submitting the representations;
- (d) Whether the person submitting the representations requests the Board to determine that such person's identity may be divulged and the grounds for such request; and
- (e) Whether or not they wish to make oral representations at the hearing of the applicant.
