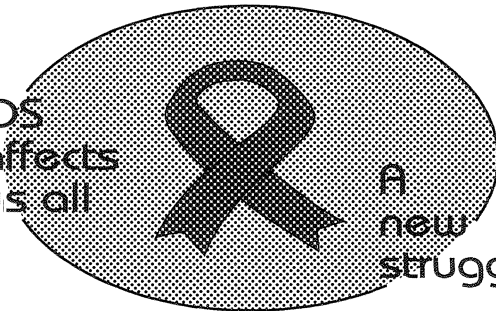

### NOTICE 341 OF 2015

#### NOTICE OF INTENTION TO VEST THE GOVERNANCE OF TWO OR MORE PUBLIC SCHOOLS IN A SINGLE GOVERNING BODY IN GAUTENG PROVINCE.

1. By virtue of the powers vested in me in terms of Section 17 of the South African Schools Act (Act 84 of 1996) I, Andrek Lesufi, the Member of the Executive Council responsible for Education, hereby officially gazette my intention that the governance of schools listed in 3 below, is to be vested in a single governing body.
2. Reason for the governance to be vested in a single governing body:
  - It will be in the best interest of education at the schools in question due to:
    - The transfer of skills which will impact positively of teaching and learning and governance at the selected schools;
    - Improved learner outcomes through the holistic development of the child;
    - Improved social cohesion and integration of all stakeholders associated with the respective schools;
    - Improved cultural awareness;
    - Optimum utilisation of scarce resources.
