

- 2.3 The Municipal Manager of Tshwane Metro, Mogale City and Nokeng tsa Taemane Municipalities did not call a by-election as requires and the Independent Electoral Commission now request the MEC to proclaim the by-election and set the date as 12 November 2008 in resonance with the by-election time table attached hereto as Annexure "A".
- 2.4 In view of the above, it is therefore suggested that the MEC in terms of section 25(4) of the Act, call and set a date for the by-election in Ward 22 City of Tshwane, Ward 2 of Mogale City and ward 4 of Nokeng tsa Taemane Municipalities.
- 2.5 It is further suggested that the date for the by-election be set for 10 December 2008 as suggested by IEC.
- 2.6 A notice for publication in the Provincial Gazette is drafted and attached hereto for the signature of the MEC.
