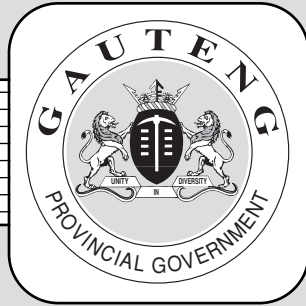

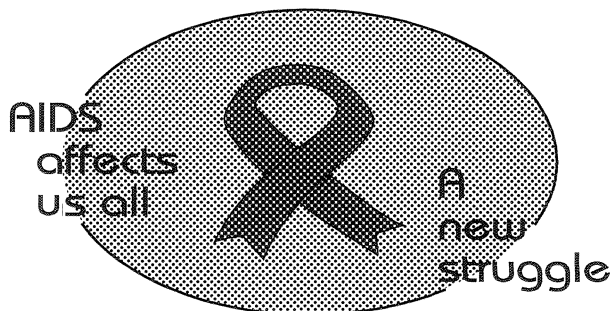

BEDFORDVIEW AMENDMENT SCHEME 1648**

It is hereby notified in terms of section 57(1) of the Town Planning and Townships Ordinance, 15 of 1986 that the Ekurhuleni Metropolitan Municipality has approved the amendment of the Bedfordview Town Planning Scheme, 1995, by the rezoning of Erf 2010 Bedfordview Extension 282 from "Business 4" to "Business 4" subject to amended conditions to include the use of a place of instruction.

Map 3 and the scheme clauses of the amendment scheme are filed with the Director-General, Gauteng Provincial Administration: Economic Development, Matlotlo Extension, 31 Simmonds Street, Johannesburg and the Area Manager: Edenvale Customer Care Centre, Corner van Riebeeck Avenue and Hendrik Potgieter Street, Edenvale and are open for inspection at all reasonable times.

The amendment scheme is known as Bedfordview Amendment Scheme 1648 and shall come into operation from the date of publication of this notice.
