Notice is hereby given that Phumelela Gaming and Leisure Limited intend submitting an application to the Gauteng Gambling Board for the relocation of a Branch Licence, from ERF 1842, Tatts Building, facing 6th Street North, Springs to Shop number 4, 5 and 6; ERF 922, First Avenue East and Second Avenue East, Geduld, Springs, Gauteng.

The application will be open for public inspection at the offices of the Board from 30 November 2018.

Attention is directed to the provision of Section 20 of the Gauteng Gambling Act No. 4 of 1995 (as amended), which makes provision for the lodging of written representations in respect of the application.

Written representations should be lodged with the Chief Executive Officer, Gauteng Gambling Board, Private Bag 15, Bramley, 2018, within one month from 30 November 2018.

Such representations shall contain at least the following information:

- (a) the name of the applicant to which representations relate;
- (b) the ground or grounds on which representations are made;
- (c) the name, address, telephone and fax number of the person submitting the representations
- (d) whether the person submitting the representations requests the board to determine that such person's identity may not be divulged and the grounds for such request; and
- (e) whether or not they wish to make oral representations at the hearing of the application.
