




NOTICE FOR THE PROPOSAL TO CLOSE AND MERGE SCHOOLS IN DISTRICT TSHWANE NORTH

 - 1.3 Thulasizwe P/S to close and to merge with Phumzile P/S. The remaining facility to be given to ABET satellite.
 - 1.4 Khutso P/S to close and to merge with Tipfuxeni P/S. The remaining facility to be given to ABET satellite.

2. The reasons for the proposed merger are the following:
 - 2.1 To ensure compliance by the Department with the provisions of the Public Finance Management Act (Act No. 1 of 1999) and Section 195 of the Constitution of RSA, Act 108 of 1996 to use the resources of the state cost effectively and efficiently. There is a serious under-utilization of space of all the schools. Only 70 classrooms out of 156 are utilized. A total of 86 classrooms are standing empty.
 - 2.2 Educators are not gainfully used due to redeployment in respect of declining learner numbers.

3. The governing bodies of the above mentioned schools and any other interested parties are invited to make representations within 90 days of this notice. You can forward your representation to the following:






