### CALL FOR NOMINATIONS OF CANDIDATES TO SERVE AS MEMBERS OF THE GAUTENG TOURISM AUTHORITY BOARD

The Member of the Executive Council responsible for Economic Development hereby calls for the nomination of candidates for consideration, to serve on the Board of Directors of Gauteng Tourism Authority.

In terms of section 5(1)(a)-(c) of the Gauteng Tourism Act no.10 of 2001, as amended; the MEC must constitute a Board of not less than seven (7) and not more than ten (10) members including:

- (a) Officials from the Metropolitan Municipalities in the Province
- (b) Officials from the District Municipalities in the Province

Section 3 (a)-(b) of the Gauteng Tourism Act no.10 of 2001, as amended states that the MEC must ensure that the members of the Board-

- (a) Are broadly representative of the population of the Province; and
- (b) Have sufficient knowledge, experience or qualifications relating to tourism in the Province and the responsibilities of the Board.

Section 5C (1) (a)-(d) of the Act state that a person may not be appointed as a member of the Board if he or she-

- a) Is an unrehabilitated insolvent
- b) Is convicted of an offence and has been sentenced to imprisonment without the option of a fine
- c) Has, as a result of improper conduct, been removed from an office of trust; or
- d) Has been declared by a court to be mentally ill or disordered.

All interested persons are hereby invited to submit their written nominations for appointment as members of the Gauteng Tourism Authority, Board of Directors.

The nomination must include:

- a) Full name of the nominee
- b) A certified copy of the nominee's Identity Document
- c) A certified copy of the nominee's qualifications
- d) Detailed Curriculum Vitae of the nominee
- e) Motivation for the nomination
- f) A letter from the nominee agreeing to serve as a member of the Board

A person may only nominate himself or herself.

**The closing date for the application/nomination is 21 April 2011**  
Application/nominations received after the closing date will not be considered.
