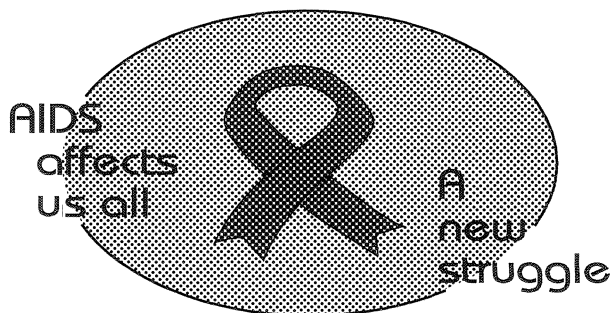

I, Nomusa Dube-Ncube, in my capacity as Member of the KwaZulu-Natal Executive Council responsible for local government, and after the Minister of Finance has, in terms of section 23(4)(c) of the Local Government: Municipal Demarcation Act, 1998, decided to defer the effective date of all municipal boundary redeterminations to the date of the 2016 local government elections, hereby amend Provincial Notice No. 57, published in *Provincial Gazette* No. 1111, dated 10 March 2014, by the substitution in the notice for the words "1 July 2014", of the words "the date of the 2016 local government elections".
