

Zikalala, acting in my capacity as Premier of KwaZulu-Natal, and in terms of the powers vested in me by section 21(1)(e) and (f) of the KwaZulu-Natal Traditional Leadership and Governance Act, 2005 (Act No. 5 of 2005), hereby withdraw the recognition of Bhekizwe Nivard Luthuli as *iNkosi* for the Thulini Traditional Community in the Ugu District, with effect from the date of signature hereof, as a result of charges of misconduct levelled against him.
