NOTICE IN TERMS OF SECTION 16(3)(c) OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998 (ACT NO. 117 OF 1998): DR NKOSAZANA DLAMINI ZUMA MUNICIPALITY

1. The Member of the KwaZulu-Natal Executive Council responsible for Co-operative Governance and Traditional Affairs, in his capacity as the Member of the Executive Council responsible for local government, under the powers vested in him by section 16(1)(d) of the Local Government Municipal Structures Act, 1998 (Act No. 117 of 1998), to amend notices issued in terms of section 12 of the said Act, and in order to give effect to a decision by the Municipal Council of the Dr Nkosazana Dlamini Zuma Municipality to designate one Executive Committee member as a full-time Councillor, proposes to publish the following notice:


