Notice is hereby given that Phumelela Gaming and Leisure (Pty) Ltd – Malamulele with Registration Number: 1997/016610/06, trading as TAB – Malamulele, intends submitting an application for relocation of a Totalisator Licence, in terms of Section 38 of the Limpopo Gambling Act 3 of 2013, on 20 July 2018.

The purpose of the application is to obtain permission to relocate and operate the Totalisator Licence from Portion 1 of Erf 1, Malamulele A, Shop no. 17, Malamulele Crossing, Limpopo to ERF 10A, Malamulele BA, Malamulele Crossing, Limpopo.

If successful the duration of the licence is in perpetuity, subject to continuous suitability.
