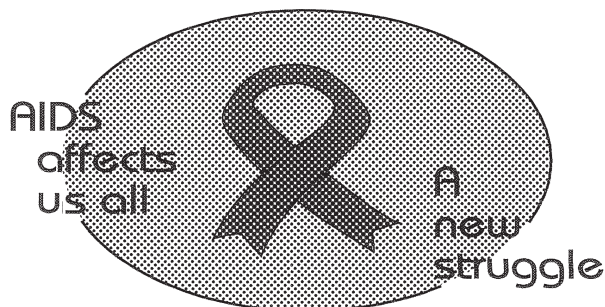

The purpose of this application is to transfer the license from Johanna Cornelia Slabber to Ahmedi Kangomba Milanzi to operate the Totalisator Agency at the abovementioned premises in Limpopo Province.

Application will be open to public inspection at the offices of the Board from 3 October 2022. Attention is directed to the provisions of Section 20 of the Gauteng Gambling Act No 4 of 1995 (as amended) which makes provision for the lodging of written representations in respect of the application.

- (d) Whether the person submitting the representations requests the board to determine that such person's identity may not be divulged and the grounds for such request; and
- (e) Whether or not they wish to make oral representations at the hearing of the application.
