**NOTICE 318 OF 2008**

**NATIONAL ROAD TRAFFIC ACT, 1996 (ACT NO.93 OF 1996) AND ROAD TRAFFIC ACT, 1989 (ACT NO.29 OF 1989) READ WITH SECTION 93(3) OF THE NATIONAL ROAD TRAFFIC ACT, 1996, (ACT NO.93 OF 1996): NOTICE OF REGISTRATION OF TESTING STATION AND AUTHORITY TO APPOINT EXAMINERS OF VEHICLES**

I, Jackson Mphikwa Mthembu, Member of Executive Council for Roads and Transport hereby give notice in terms of Section 39 of the National Road Traffic Act, 1996 (Act no.93 of 1996), of the registration of the testing station of **Supreme Testing Station, with infrastructure number 4148006Z** as an A Grade testing station; and

Hereby determine under Section 3(1)(e) of the Road Traffic Act, 1989 (Act no.29 of 1989) read with Section 93(3) of the National Road Traffic Act, 1996 (Act no.93 of 1996), **Supreme Testing Station, with infrastructure number 4148006Z**, as an authority which may appoint any person as an examiner of vehicles for any area on condition that such person-

- has obtained a diploma in the examination for examiners of vehicles at a centre approved by the Minister of Transport; and
- is appointed on condition that he may only examine vehicles at the testing station of Supreme Testing Station.
