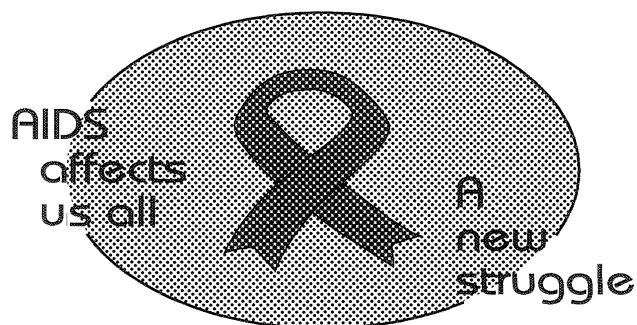

Notice is hereby given in terms of section 49(1) (a) (i) of the Local Government Municipal Property Rates Act, 2004 (Act No. 6 of 2004), hereinafter referred to as the "Act", that the Interim Supplementary Valuation Roll for the financial years 1 July 2014 to 30 June 2018 is open for public inspection at Rustenburg Local Municipality from 11 June 2014 to 15 July 2014. In addition, the Interim Supplementary Valuation Roll is available on our website www.rustenburg.gov.za and at the following venues:-

An invitation is hereby made in terms of section 49(1)(a)(1) of the Act that any owner of property or other persons who so desires should lodge an objection with the Acting Municipal Manager in respect of any matter reflected in, or omitted from, the general valuation roll within the abovementioned period.

Attention is specifically drawn to the fact that, in terms of Section 50 (2) of the Act, an objection must be in relation to a specific individual property and not against the general valuation roll as such.
