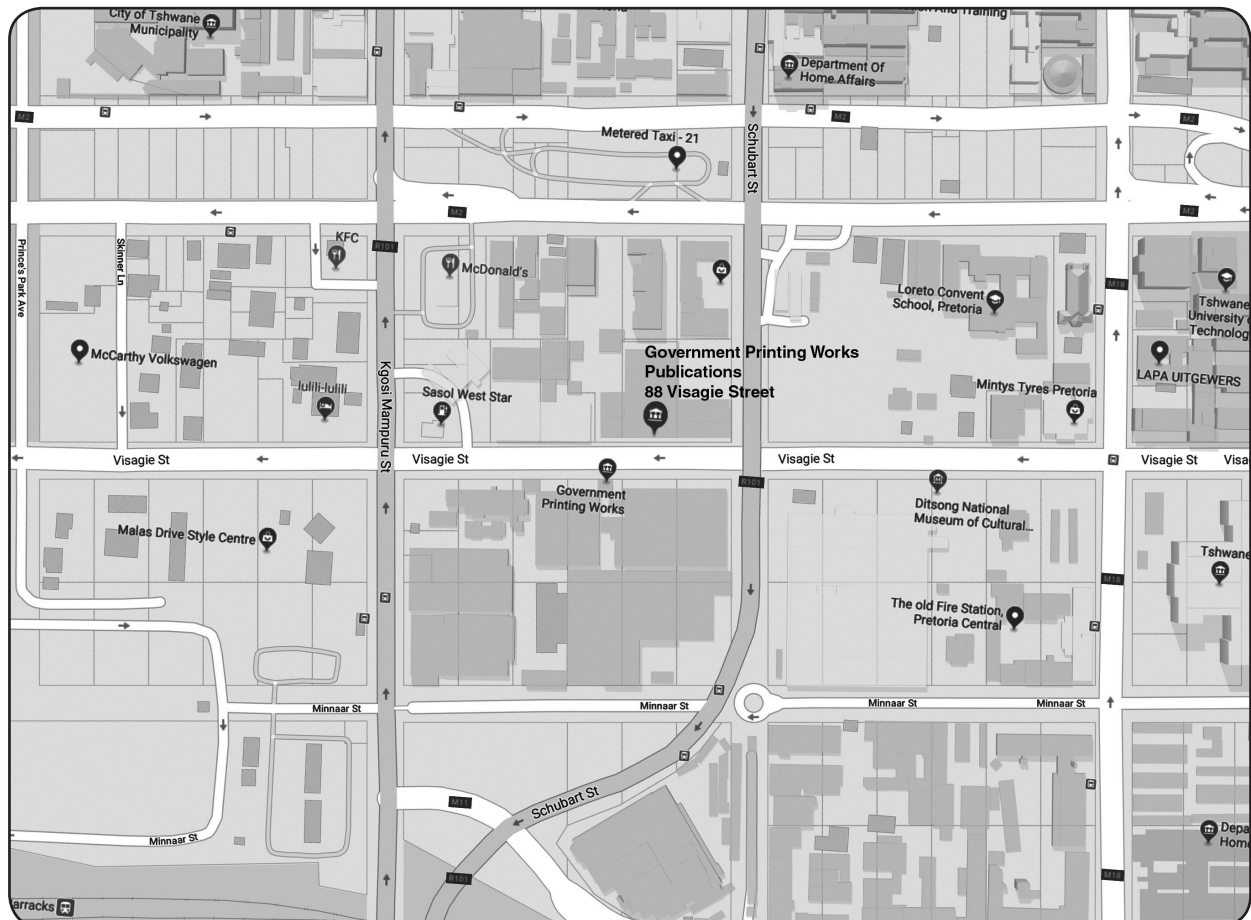

NOTICE IN TERMS OF SECTION 29 OF THE NORTH WEST GAMBLING ACT,  
2001 (ACT No. 2 OF 2001), AS AMENDED.

APPLICATION FOR REMOVAL OF BUSINESS TO OTHER PREMISES IN TERMS OF SECTION 45  
OF THE NORTH WEST GAMBLING ACT, 2001.

Notice is hereby given in terms of the provisions of section 29 of the North West Gambling Act, 2001 (Act No. 2 of 2001), as amended ("the Act"), that the North West Gambling Board ("the Board") received an application from Khumofon (Pty) Ltd for the removal of gambling business from the current approved licensed premises to other premises.

On 26 February 2019 the Board published a notice informing the public that Khumofon (Pty) Ltd lodged an application in terms of the provisions of section 45 of the Act to remove their Independent Site Operator Licence operation from the licensed premises at **Shop No. 03, Hebron Mall, Hebron** to the new premises situated at **Shop No. 2B Midtown Mall, Loop Street, Rustenburg**.

The notice further indicated that the application will be lying open for public inspection at the offices of the North West Gambling Board at 131 University Drive, Mmabatho, **between 08h30 – 16h30, for a period of one (1) month, commencing on 01 March 2019 until 31 March 2019**.

Subsequent to the above, Khumofon (Pty) Ltd lodged an application for amendment of their application for removal of business in terms of Regulation 4 (4) of the North West Gambling Regulations 2002. Read together with the provisions of section 45 of the North West Gambling Act 2001, to remove their Independent Site Operator Licence operation from the licensed premises at **Shop No. 03, Hebron Mall, Hebron** to the new premises situated at **1 Augrabies Avenue, Waterfall Value Mart Rustenburg**.

Please take note that this application will be lying open for public inspection at the offices of the North West Gambling Board at 131 University Drive, Mmabatho, **between 08h30 – 16h30, for a period of one (1) month, commencing on 01 August 2019 until 31 August 2019**.

**Persons wishing to make representations, be either comments or objections, in relation to any application submitted to the Board, shall do so in writing and such representations shall contain the following information:**

- a) The name of the applicant to which representations relate;
- b) The grounds on which representations are made;
- c) The name, address, telephone, and facsimile numbers of the person submitting representations;

- d) Whether or not the person making representations wish to make an oral presentation at the hearing of the application.
