PUBLIC NOTICE CALLING FOR INSPECTION OF THE THIRD GENERAL VALUATION ROLL AND LODGING OF OBJECTIONS – IMPLEMENTATION DATE 1 JULY 2022

Notice is hereby given as required in terms of section 49(1)(a) & (c) of the Local Government: Municipal Property Rates Act, 2004 (Act No.6 of 2004) as amended, hereinafter referred to as the "Act" that the general valuation roll for the period 01 July 2022 to 2027/06/30 with implementation date 1 July 2022 is open for inspection during office hours (08h10 till 15H30) from **14 February 2022 to 08 April 2022**.

The purpose of this notice is to advise you of the valuation placed on your property as at 1 September 2021 being the date of valuation in line with Section 31 of the Act.

An invitation is hereby made in terms of Section 49(1)(a)(ii) of the Act that any owner of property or other person who so desire should lodge an objection with the municipal manager in respect of any matter reflected in, or omitted from, the general valuation roll within the period stated above.

Attention is specifically drawn to the fact that in terms of Section 52(2) of the Act an objection must be in relation to a specific individual property and not against the valuation roll as such.

The prescribed form for lodging of an objection is obtainable during office hours (08H10 – 15H30) from 14 February 2022 to 08 April 2022 at the following Municipal offices:
