### SCHEDULE

#### 1. Amendment to paragraph 3 of the Notice

1.1. Paragraph 3 of Official Notice No. 10 of 2007 is hereby amended by the substitution for subparagraph (6) of the following sub-paragraph:

(6) The school governing body must designate a disciplinary committee consisting of three persons: The members of the disciplinary committee must, at all times, act in a manner that is not intimidating to learners.
