PUBLICATION OF THE NORTHERN CAPE YOUTH COMMISSION ACT REPEAL BILL 2009

NORTHERN CAPE YOUTH COMMISSION ACT REPEAL BILL, 2009**BILL**

To repeal the Northern Cape Youth Commission Act 1 of 2005; and to provide for matters connected therewith.

BE IT ENACTED BY the Provincial Legislature of the Province of the Northern Cape, as follows:—

1. Definitions

In this Act, unless the context indicates otherwise –

“**the Act**” means the Northern Cape Youth Commission Act, 2005 (Act 1 of 2005).

“**chairperson**” means the Chairperson of the Northern Cape Youth Commission;

“**commission**” means the Northern Cape Youth Commission, established by the Act;

“**Premier**” means the Premier of the Northern Cape Province elected as contemplated in section 128 of the Constitution and includes an acting Premier as contemplated in section 131 of the Constitution;

2. Disestablishment of the Northern Cape Youth Commission

The Northern Cape Youth Commission established in terms of Section 2 of the Act, is hereby disestablished.

3. Transitional Provisions

- (1) When this Act comes into operation:-
 - (a) all assets, rights, obligations and liabilities of the Commission must be transferred to the Office of the Premier without payment of any transfer duties, stamp duties, fees or taxes: Provided that the Public Finance Management Act, 1999 (Act 1 of 1999) is adhered to.
 - (b) the staff of the Commission must be transferred to the Northern Cape Provincial Administration subject to the provisions of the Labour Relations Act, 1995 (Act No. 66 of 1995).
- (2) The Accounting Officer in the Office of the Premier in consultation with the Chief Executive Officer and the chairperson of the Commission are responsible for the finalization of all matters of the Commission.
- (3) The Premier may issue directives in so far as may be necessary to give effect to the provisions of Section 3.

4. Repeal Laws

The whole of the Northern Cape Youth Commission Act, 2005 (Act 1 of 2005) is hereby repealed.

5. Short title and commencement

- (1) This Act is called the Northern Cape Youth Commission Act Repeal Act, 2009 and comes into effect on a date proclaimed by the Premier in the *Provincial Gazette*.
 - (2) Different dates may be determined by the Premier in terms of subsection (1) with regard to coming into operation of the different provisions of this Act.
