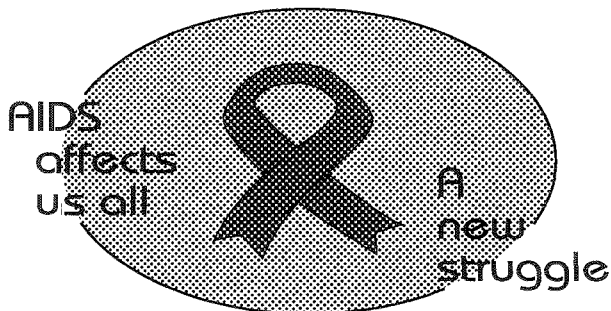

#### **NOTICE IN TERMS OF SECTION 31 OF THE NORTHERN CAPE CONSUMER PROTECTION ACT, 2012 (ACT NO. 1 OF 2012): REMUNERATION OF FUNCTIONARIES OF CONSUMER PROTECTION ENTITIES**

In terms of the powers vested in me by section 31 of the above Act, I, John Block, MEC for Finance, Economic Development and Tourism hereby determine the remuneration payable to functionaries of consumer protection entities as follows:

##### **Provincial Consumer Protector**

Equal to that of a Chief Director (level 14) in the Public Service.

##### **Deputy Consumer Protector**

Equal to that of a Director (level 13) in the Public Service.

##### **Chairperson of the Consumer Court**

Equal to that of a Director (level 13) in the Public Service, if appointed in a full time capacity.

##### **Registrar of the Consumer Court**

Equal to that of a Deputy Director (level 12) in the Public Service.
