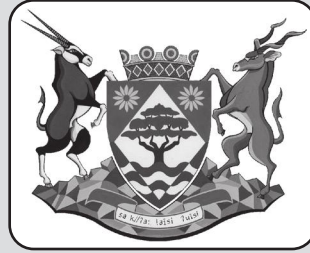

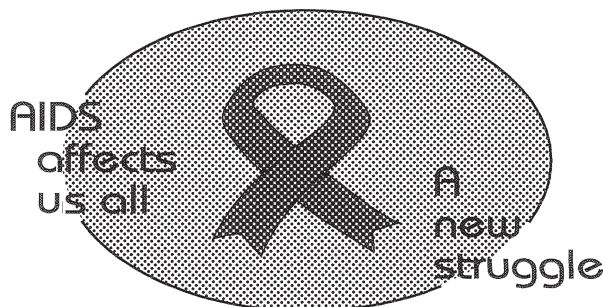

Notice is hereby given in terms of Section 49 (1) (a) (i) of the Local Government: Municipal Property Rates Act, 2004 (Act 6 of the 2004), hereinafter referred to as the "Act", that the valuation roll for the financial years 1 July 2021 to 30 June 2026 is open for public inspection at the following venues: -

1. Municipal offices, Church Street, Hopetown;
2. Municipal offices, Badenhorst Street, Strydenburg; and

As well as the Council website www.thembelihlemunicipality.gov.za from **19 February 2021 to 15 May 2021**.

An invitation is hereby made in terms of Section 49 (1) (a) (ii) of the Act that any owner of property or other person who so desires should lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from, the valuation roll within the above-mentioned period.

Attention is specifically drawn to the fact that in terms of Section 50 (2) of the Act an objection must be in relation to a specific individual property and not against the valuation roll as such.

The completed objection forms must be returned to the abovementioned municipal offices.
