

I, Marthinus Christoffel Johannes van Schalkwyk, Minister of Environmental Affairs and Tourism, by virtue of the powers vested in me in terms of section 8 of the World Heritage Convention Act, 1999 (Act No. 49 of 1999), hereinafter referred to as "the Act", hereby declare the Gauteng Member of the Executive Council responsible for the Fossil Hominid Sites of Sterkfontein, Swartkrans, Kromdraai and Environs World Heritage Site as the Authority for the site for a term of five years subject to a performance review.

The Authority shall exercise only those powers and duties referred to in section 13 (2) of the Act in connection with the Fossil Hominid Sites of Sterkfontein, Swartkrans, Kromdraai and Environs World Heritage Site.

In order for the Authority to be able to perform its duties, I, furthermore declare that sections 33, 35, 36, 37, 39, 40 (1 & 2) and 42 of the Act shall apply to the Authority.






