1. In these regulations, "the Regulations" means the South African Civil Aviation Passenger Safety Charge Regulations, 2001, published by Government Notice No R.302 of 30 March 2001, as amended by Government Notice No R.158 of 31 January 2003 Government Notice No R.1848 of 31 December 2003, and Government Gazette No.28213 dated 9 November 2005.

**Amendment of Regulations 2 of the Civil Aviation Aircraft Passenger Safety Charge**

2. Regulation 2 of the said Regulations is herewith amended by the substitution for the amount of "R6-00" of the amount of "R10-00" in the first line of sub-regulation 1.

**Short title and commencement**

3. These Regulations shall be called the Fourth Amendment of the South African Civil Aviation Aircraft Passenger Safety Charge Regulations, 2001, and shall come into operation on the 01 January 2008.
