PETROLEUM PRODUCTS ACT, 1977 (ACT No. 120 OF 1977)
**REGULATIONS IN RESPECT OF THE SINGLE MAXIMUM NATIONAL
RETAIL PRICE FOR ILLUMINATING PARAFFIN**

1. Ms. Buyelwa P. Sonjica, Minister of Minerals and Energy, under section 2(1)(c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), determine that a maximum retail price for illuminating paraffin (excluding the price of any form of packaging) will become effective on the first Wednesday of each month.
2. The maximum retail price for illuminating paraffin, excluding the price of any form of packaging, for the period 2 July 2008 to 5 August 2008 will be 1,251 c/l.
3. **Commencement**
These regulations shall come into operation at **00:01 on 2 July 2008.**

AMENDMENT OF THE REGULATIONS IN RESPECT OF PETROLEUM PRODUCTS
