**PETROLEUM PRODUCTS ACT, 1977 (ACT No. 120 OF 1977)**

**REGULATIONS IN RESPECT OF THE SINGLE MAXIMUM NATIONAL  
RETAIL PRICE FOR ILLUMINATING PARAFFIN**

1. **Ms. Buyelwa P. Sonjica, Minister of Minerals and Energy, under section 2(1)(c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), determine that a maximum retail price for illuminating paraffin (excluding the price of any form of packaging) will become effective on the first Wednesday of each month.**
  
2. **The maximum retail price for illuminating paraffin, excluding the price of any form of packaging, for the period 6 August 2008 to 2 September 2008 will be 1256.0 c/l.**
  
3. **Commencement**  
 These regulations shall come into operation at 00:01 on 6 August 2008.

AMENDMENT OF THE REGULATIONS IN RESPECT OF PETROLEUM PRODUCTS

The Minister of Minerals and Energy has, under section 2 (1) (c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), made the regulations set out in the Schedule.
