**JUDGES' REMUNERATION AND CONDITIONS OF EMPLOYMENT ACT, 2001:
AMENDMENT OF REGULATIONS**

The President has under section 13 of the Judges' Remuneration and Conditions of Employment Act, 2001 (Act No. 47 of 2001), made the regulations in the Schedule.

SCHEDULE

Definitions

1. In this Schedule –

“the Regulations” means the regulations published by Government Notice No. R. 894 of 5 July 2002, as amended by Government Notices No. R. 1594 of 10 December 2003, R. 250 of 22 March 2005 and R. 415 of 29 April 2005.

Amendment of regulations 11(3), 13(1)(a) and (b) and 18(3) of the Regulations

2. Regulations 11(3), 13(1)(a) and (b) and 18(3) of the Regulations are hereby amended by the substitution for the expression “R1,98 per kilometre” of the expression “R2,38 per kilometre”.

Amendment of regulation 14 of the Regulations

3. Regulation 14(1)(a) of the Regulations is hereby amended by the substitution for the expression “R660” of the expression “R792”.

4. Regulation 14(3) of the Regulations is hereby amended by the substitution for the expression “R121” of the expression “R145”.

Amendment of regulation 17 of the Regulations

5. Regulation 17 of the Regulations is hereby amended by the substitution for the expression “R300” of the expression “R360”.
