

**AMENDMENT OF THE REGULATIONS FOR THE SOUTH AFRICAN  
POLICE SERVICE**

The Minister of Police has, under section 24(1) of the South African Police Service Act, 1995 (Act No. 68 of 1995), made the regulations in the Schedule.

**SCHEDULE**

**1. DEFINITION**

In these regulations "the Regulations" mean the South African Police Service Employment Regulations, 2008, promulgated by Government Notice R.973 of 12 September 2008.

**2. SUBSTITUTION OF REGULATION 44(3) OF THE REGULATIONS**

Regulation 44(3) of the Regulations is hereby amended by the substitution for regulation 44(3) of the following regulation:

"44 (3) The National Commissioner must advertise any vacant post in the *SMS* nationally, as a minimum, inside the Service, but may also advertise such post simultaneously both inside and outside the Service."

#### 1. WOORDOMSKRYWINGS

In hierdie regulasies beteken "die Regulasies" die Suid Afrikaanse Polisie Diensregulasies, 2008, uitgevaardig deur Goewermentskennisgewing R.973 van 12 September 2008.

#### 2. VERVANGING VAN REGULASIE 44(3) VAN DIE REGULASIES

Regulasie 44(3) van die Regulasies word hiermee gewysig deur die vervanging van regulasie 44(3) met die volgende regulasie:

- "44. (3) Die Nasionale Kommissaris moet enige vakante pos in die *SBD* nasionaal adverteer, ten minste binne die Diens, maar kan ook sodanige pos gelyktydig binne en buite die Diens adverteer."
