PLANT IMPROVEMENT ACT, 1976
(ACT No. 53 OF 1976)

DECIDUOUS FRUIT PLANT CERTIFICATION SCHEME: AMENDMENT

The Minister of Agriculture, Forestry and Fisheries, acting under Section 23 of the Plant Improvement Act, 1976 (Act No. 53 of 1976), hereby amend the Deciduous Fruit Plant Certification Scheme published under Government Notice No. R. 1971 of 15 October 1993, to the extent set out in the Schedule.

SCHEDULE

Definition

1. In this Schedule "the Scheme" means the Deciduous Fruit Plant Certification Scheme published by Government Notice No. R. 1971 of 15 October 1993, as corrected by Government Notice No. R. 453 of 22 March 1996 and amended by Government Notice Nos. R. 564 of 18 April 1997, R. 1305 of 10 October 1997 and R. 262 of 5 March 1999.

Amendment of Section 4 of the Scheme

2. Section 4 of the Scheme is hereby amended by the substitution of subsection 4.5 with the following:

- 4.5 Notwithstanding anything to the contrary contained in this section, the authority may determine that all the provisions of this Scheme shall apply to such other varieties and clones of deciduous fruit as the Authority may determine.

Amendment of Section 6 of the Scheme

3. Section 6 of the Scheme is hereby amended by the deletion of subsection 6.7.

Amendment of Section 9 of the Scheme

4. Section 9 of the Scheme is hereby amended by the substitution of the expression "19" with the expression "20" in subsection 9.7

Amendment of Section 11 of the Scheme

5. Section 11 of the Scheme is hereby amended by the deletion of subsection 11.4

Amendment of Section 13 of the Scheme

6. Section 13 of the Scheme is hereby substituted with the following:

13. **Inspection of units [23; 24(1)(h)]**

13.1 The plants established on a unit with a view to the cultivation of nucleus plants or foundation plants shall be inspected annually by the authority during –

- 13.1.1 the early active growth stage thereof;
 - 13.1.2 the early leaf fall stage thereof; and
 - 13.1.3 the dormant stage thereof.
- 13.2 The plants established on a unit with a view to the cultivation of mother plants –
- 13.2.1 shall be inspected by the authority at least once per year; and
 - 13.2.2 such inspections shall be made annually on an alternate basis at the stages referred to in subsection (1).
- 13.3 The plants established on a unit with a view to the cultivation of nursery plants or foundation nursery plants shall be inspected annually by the authority during –
- 13.3.1 the early active growth stage thereof;
 - 13.3.2 the early leaf fall stage thereof; and
 - 13.3.3 the dormant stage thereof.
- 13.4 The authority may carry out as many additional inspections of a unit as it may deem necessary.
- 13.5 If the authority fails to carry out any inspection referred to in section 13.1, 13.2 and 13.3, the certification of the plant material cultivated on the unit concerned shall not be refused solely on account thereof.

Amendment of Section 17 of the Scheme

7. Section 17 of the Scheme is hereby amended by the substitution of subsection 17.1 with the following:
- 17.1 Foundation nursery plants and nursery plants of pome and stone fruit shall be marked in accordance with the marking requirements specified in Part 6 of Schedule 1 before it is lifted from the soil of the unit on which it is grown.

Amendment of Section 19 of the Scheme

8. Section 19 of the Scheme is hereby amended by the substitution of subsection 19.4 with the following:
- 19.4 Each participant shall submit to the authority annually, on the dates determined by the authority, a return on a form and in a manner determined by the authority, of the particulars recorded in terms of this section.

Amendment of Section 20 of the Scheme

9. Section 20 of the Scheme is hereby amended by the substitution of the expression "destroy" with the expression "retain" in paragraph 20.2.1 of subsection 20.2.
10. Paragraph 20.2.2 is hereby amended by deleting the words "and destroy" in order to align it with the Afrikaans text of the Scheme.

Amendment of Part 4 of Schedule 2 of the Scheme

11. Part 4 of Schedule 2 of the Scheme is hereby amended by the substitution of paragraphs 4.9.2, 4.9.6, 4.9.7, 4.10.2. and 4.10.3 with the following:

- 4.9.2 The diameter of the two year old part of the scion of such plant shall be at least 6,0 mm.
- 4.9.6 Each such plant shall have at least one mature shoot that shall –
- 4.9.6.1 in the case of plants of the varieties Barlinka, Dauphine, Muscat 'd Alexandrie and Sugrasixteen, be at least 100 mm in length and with an internodium diameter of 3,0 mm at a 50 mm length; and
- 4.9.6.2 otherwise be at least 150 mm in length with an internodium diameter of 3,0 mm at a 50 mm length.
- 4.9.7 The rootstock of each such plant shall be at least 200 mm in length and with a diameter of at least 6,5 mm.
- 4.10.2. Each such plant shall have at least one mature shoot that shall –
- 4.10.2.1 in the case of plants of the varieties Barlinka, Dauphine, Muscat 'd Alexandrie and Sugrasixteen, be at least 100 mm in length and with an internodium diameter of 3,0 mm at a 50 mm length; and
- 4.10.2.2 otherwise be at least 150 mm in length with an internodium diameter of 3,0 mm at a 50 mm length.
- 4.10.3 The two-year-old stem of each plant shall be at least 200 mm in length and with a diameter of at least 6,5 mm.

Die Minister van Landbou, Bosbou en Visserye, handelende kragtens Artikel 23 van die Plantverbeteringswet, 1976 (Wet No. 53 van 1976), wysig hierby die Sagtevrugtesertifiseringskema gepubliseer by Goewermentskennisgewing No. R. 1971 van 15 Oktober 1993, tot die mate in die Bylae uiteengesit.

BYLAE

Woordomskrywing

1. In hierdie Bylae beteken "die Skema" die Sagtevrugteplantsertifiseringskema gepubliseer by Goewermentskennisgewing No. R. 1971 van 15 Oktober 1993, soos verbeter deur Goewermentskennisgewing No. R. 453 van 22 Maart 1996 en gewysig deur Goewermentskennisgewing Nos. R. 564 van 18 April 1997, R. 1305 van 10 Oktober 1997 en R. 262 van 5 Maart 1999.

Wysiging van Artikel 4 van die Skema

2. Artikel 4 van die Skema word hierby gewysig deur subartikel 4.5 met die volgende te vervang:

- 4.5 Ondanks enige andersluidende bepalings in hierdie artikel kan die gesag bepaal dat al die bepalings van hierdie Skema van toepassing is op die ander variëteite en klone van sagtevrugte soos wat die Gesag bepaal.

Wysiging van Artikel 6 van die Skema

3. Artikel 6 van die Skema word hierby gewysig deur die skraping van subartikel 6.7.

Wysiging van Artikel 9 van die Skema

4. Artikel 9 van die Skema word hierby gewysig deur die uitdrukking "19" in subartikel 9.7 met die uitdrukking "20" te vervang.

Wysiging van Artikel 11 van die Skema

5. Artikel 11 van die Skema word hierby gewysig deur die skraping van subartikel 11.4

Wysiging van Artikel 13 van die Skema

6. Artikel 13 van die Skema word hiermee deur die volgende vervang:

13. **Onderzoek van eenhede [23; 24(1)(h)]**

13.1 Die plante wat op 'n eenheid gevestig is met die oog op die verbouing van kernplante of grondvesplante, moet jaarliks deur die gesag ondersoek word tydens-

- 13.1.1 die vroeë aktiewe groeistadium daarvan;
 - 13.1.2 die vroeë blaarvalstadium daarvan; en
 - 13.1.3 die russtadium daarvan.
- 13.2 Die plante wat op 'n eenheid gevestig is met die oog op die verbouing van moederplante -
- 13.2.1 moet minstens een keer per jaar deur die gesag ondersoek word; en
 - 13.2.2 sodanige ondersoeke moet jaarliks op 'n beurtelinge grondslag tydens die stadiums in subartikel (1) bedoel, gedoen word.
- 13.3 Die plante wat op 'n eenheid gevestig is met die oog op die verbouing van kwekeryplante of grondves kwekeryplante, moet jaarliks deur die gesag ondersoek word tydens -
- 13.3.1 die vroeë aktiewe groeistadium daarvan;
 - 13.3.2 die vroeë blaarvalstadium daarvan; en
 - 13.3.3 die russtadium daarvan.
- 13.4 Die gesag kan soveel bykomende ondersoeke van 'n eenheid uitvoer as wat hy nodig ag.
- 13.5 Indien die gesag versuim om die vereiste ondersoek in subartikels 13.1, 13.2 en 13.3 bedoel uit te voer, word die sertifisering van die plantmateriaal wat op die betrokke eenheid verbou is, nie slegs uit hoofde daarvan geweier nie.

Wysiging van Artikel 17 van die Skema

7. Artikel 17 van die Skema word hierby gewysig deur subartikel 17.1 met die volgende te vervang:
- 17.1 Grondveskwekeryplante en kwekeryplante van kern- en steenvrugte moet ooreenkomstig die merkvereistes in Deel 6 van Bylae 1 uiteengesit, gemerk word voordat dit uit die grond van die eenheid waarin dit gekweek is, uitgehaal word.

Wysiging van Artikel 19 van die Skema

8. Artikel 19 van die Skema word hierby gewysig deur subartikel 19.4 met die volgende te vervang:
- 19.4 Elke deelnemer moet jaarliks op die datums soos deur die gesag bepaal, 'n opgawe van die besonderhede wat ingevolge hierdie artikel aangeteken is, aan die gesag verstrek op die vorm en wyse deur die gesag bepaal.

Wysiging van Artikel 20 van die Skema

9. Artikel 20 van die Skema word hierby gewysig deur die uitdrukking "vernietig" in paragraaf 20.2.1 van subartikel 20.2 deur die uitdrukking "in sy bewaring hou" te vervang.
10. Subartikel 20.2.2 in die Engelse teks van die Skema word hierby gewysig deur die uitdrukking "and destroy" te skrap ten einde in ooreenstemming met die Afrikaanse teks te wees.

Wysiging van Deel 4 van Bylae 2 van die Skema

11. Deel 4 van Bylae 2 van die Skema word hierby gewysig deur die onderskeie paragrawe 4.9.2, 4.9.6, 4.9.7, 4.10.2 en 4.10.3 met die volgende te vervang:

- 4.9.2 Die deursnee van die tweejarige bostok gedeelte van sodanige plant moet minstens 6,0 mm wees.
- 4.9.6 Elke sodanige plant moet minstens een ryp loot hê wat –
- 4.9.6.1 In geval van die variëteite Barlinka, Dauphine, Muscat d'Alexandrie en Sugrasixteen minstens 100 mm lank is en waarvan die deursnee van die internodium op 'n 50 mm lengte ten minste 3,0 mm is; en
- 4.9.6.2 andersins minstens 150 mm lank is en waarvan die deursnee van die internodium op 'n 50 mm lengte ten minste 3,0 mm is.
- 4.9.7 Die onderstok gedeelte van elke sodanige plant moet minstens 200mm lank en minstens 6,5 mm in deursnee wees.
- 4.10.2 Elke sodanige plant moet minstens een ryp loot hê wat –
- 4.10.2.1 In geval van die variëteite Barlinka, Dauphine, Muscat d'Alexandrie en Sugrasixteen minstens 100 mm lank is en waarvan die deursnee van die internodium op 'n 50 mm lengte ten minste 3,0 mm is; en
- 4.10.2.2 andersins minstens 150 mm lank is en waarvan die deursnee van die internodium op 'n 50 mm lengte ten minste 3,0 mm is.
- 4.10.3 Die tweejaaroue stam van elke plant moet minstens 200 mm lank wees en minstens 6,5 mm in deursnee wees.

SCHEDULE

Definition

1. In this Schedule "the Scheme" means the South African Plant Certification Scheme for Wine Grapes published under Government Notice No. R. 2437 of 28 August 1992, as amended by Government Notice Nos. R. 3460 of 31 December 1992, R. 1084 of 25 June 1993, R. 494 of 29 March 1996, R. 322 of 19 March 1999, R. 233 of 17 March 2000 and R. 814 of 7 September 2007.

Amendment of Schedule 1 of the Scheme

2. Schedule 1 of the Scheme is hereby amended by the substitution of paragraph 4.2 with the following:
 - 4.2 The soil of the unit must be-
 - 4.2.1 virgin soil and free from vectors of grapevine fanleaf; or
 - 4.2.2 otherwise free from vectors of grapevine fanleaf


