

MEDICINES AND RELATED SUBSTANCES ACT (NO. 101 of 1965)
REGULATIONS RELATING TO A TRANSPARENT PRICING SYSTEM FOR
MEDICINES AND SCHEDULED SUBSTANCES
(SINGLE EXIT PRICE ADJUSTMENT FOR THE YEAR 2012)

The Minister of Health intends, in terms of Regulation 8 (1) of the Regulations Relating to a Transparent Pricing System for Medicines and Scheduled Substances published under the Medicines and Related Substances Act, (No.101 of 1965), to introduce a zero increase on the Single Exit Price (SEP) for the year 2012 given that the previous year yielded a negative increase.
