### CIVIL AVIATION ACT, 2009 (ACT NO. 13 OF 2009)

### CIVIL AVIATION REGULATIONS, 2011

The Minister of Transport intends, in terms of section 155(1) of the Civil Aviation Act, 2009 (Act No. 13 of 2009) and on the recommendation of the Civil Aviation Regulations Committee (CARCom), to amend the Civil Aviation Regulations, 2011, by the substitution/amendment of the following Parts:

- Part 34: Engine emission certification
- Part 36: Noise certification
- Part 127: Commercial air transport and general aviation operations: Helicopters.
- Part 187: Fees and Charges
